REP. MARGO DAVIDSON | THE QUEST FOR A NON-TOXIC WORKPLACE: STOPPING DISCRIMINATION AND SEXUAL MISCONDUCT

MARCH 4 | LANSDOWNE

Rep. Margo Davidson hosted a public hearing at East Lansdowne Borough Hall titled, "The Quest for a Non-Toxic Workplace: Stopping Discrimination and Sexual Misconduct."

Davidson was joined by legislators from across the state including state Sen. Tim Kearney and Congresswoman Mary Gay Scanlon. The legislators discussed with stakeholders how Pennsylvanians can work to eradicate misconduct in the workplace. As a tireless advocate for those who've experienced discrimination and victims of sexual misconduct, Davidson has repeatedly introduced and co-sponsored legislation addressing this issue.

State Reps. Malcolm Kenyatta and Danilo Burgos hosted a hearing at Warnock Village to discuss the health impacts of deep poverty and how to reverse the trend. Local officials and advocates talked to the committee to discuss how they can work together to create better opportunities to break the cycle of toxic poverty. Kenyatta emphasized that eradicating poverty is the moral and economic issue of our time and brought light to how we can work together to invest our resources in educating our communities, children and adults, and reduce the need for correctional and unnecessary medical costs.
