Madden Supports State Budget That Delivers For Pennsylvanians

The 2024-2025 state budget delivers key wins for Pennsylvanians. These include funding for programs to increase Pennsylvania's competitiveness in higher education and economic development, as well as more funding for infrastructure improvements, senior care, and public safety. Not least of all is the funding for public schools, which should finally deliver needed property tax relief. The budget includes no new taxes and no increase in taxes. I am confident that this budget will truly benefit our whole Commonwealth!

2024-2025 PA BUDGET WINS



- No new taxes
- **Over \$1B increase** for Pre-K to 12 education funding
- **\$30M increase** for Career and Technical Education
- **\$100M** for Public school facility improvement grants
- **NEW \$3M** investment for menstrual hygiene products in schools to address period poverty
- **Over \$15M increase** for Community Colleges
- **Over \$140M** for grants, scholarships, and other programs to make higher education more affordable in PA

Fairly Funding Public Education

- \$9.6 million increase for East Stroudsburg Area School District, \$6.3 million increase for Pocono Mountain School District, and \$4.9 million increase for Stroudsburg Area School District including funding provided for real property tax relief
- \$15.7 million increase for community colleges

Repairing Infrastructure & Public Transportation

- \$110 million increase for highway maintenance
- \$161 million for transportation and multimodal projects for 2024-25

Supporting Emergency Services & Public Safety

- \$73.5 million for Pennsylvania State Police
- \$5 million for disaster relief

Helping Seniors Age Their Way

- \$75 million increased for the care of seniors and adults with disabilities living in skilled nursing facilities
- \$2 million increase for medical assistance transportation
- \$1.9 million to create the first Alzheimer's Disease and Related Disorders Division in the PA Department of Aging



Ensuring People Get The Care They Need

- \$261 million increase for Community Waiver program for intellectually disabled
- \$274 million increase for Community HealthChoices
- \$71 million increase for mental health services
