My Office is Here to Help

The COVID-19 pandemic has not stopped us from serving you and your family. Since the onset of the health crisis, my dedicated team has been working day-in and day-out helping hundreds of constituents find solutions and resources despite often-impossible circumstances and frustrations with various government programs. Since Lackawanna County went into the "green phase" of reopening, our district office has been open by appointment. To ensure your safety and the safety of my team, we have made numerous adjustments to our office procedures, following CDC guidelines with sanitization

and social distancing in mind. In fact, most services can be delivered remotely or at your car window. Please call 570-383-9795 or email RepMullins@pahouse.net for assistance, or to make an appointment for services that require an inperson visit. We will do everything in our ability to help you with Unemployment Benefits, Pandemic Unemployment Assistance (PUA), Rent/Mortgage Assistance, COVID-19 DHS benefits/services and other state-related issues and concerns.

Unemployment Compensation Problems

Throughout the COVID-19 pandemic, my staff and I have helped hundreds of unemployed workers who reached out to our office after their calls to Unemployment Compensation offices went unanswered. This has been an extremely difficult and stressful time for so many of you, and it has been made even more difficult without having an easy way to contact an unemployment compensation officer.

The PA Department of Labor and Industry has issued more than seven million checks so far to workers who lost their jobs or were furloughed due to the COVID-19 pandemic. While the department remains focused on mailing out more to keep up with demand, there is no question it was unprepared to handle the influx of applications. I plan to dig deep into this problem and work toward solutions to ensure the system has adequate staff and resources to prevent this from happening again.

*No application needed. After the balance of your PEUC claim hits \$0, your EB claim will set up automatically, approximately two days later.

LECISLATIVE UPDATE RESPONDING TO GOVID-19

In the first few months of the COVID-19 pandemic, I voted to pass a series of emergency measures in response to the growing crisis, which included: waiving the 180-day school

requirement, changes to our election laws, critical funding for medical equipment and supplies to hospitals and other health care facilities, expanding unemployment eligibility, and grant programs for small businesses and first responders. While these measures were vitally important, there is still much more that needs to be done in the legislature to support individuals and small business owners who are still struggling mightily to make ends meet and keep their doors open.

Small Business Support

Sadly, our small business community shouldered the weight of the various closure orders. It quickly became my priority, along with state Sen. John Blake and other House and Senate Democrats to provide grants – not loans – to our smallest businesses that were hit the hardest. I was proud to support a \$225 million grant program that was passed in conjunction with our state budget in June, and I am currently fighting for more program funding to ensure we reach any small business that was financially impacted by COVID-19. Relief for Restaurants, Bars and Clubs

Our area has claim to some of the best restaurants, bars and clubs around; and the quality of our food and those who prepare it is unmatched. Most are family-owned cornerstones of our community and have hosted some of our most cherished memories - weddings, graduation parties, first dates, and retirement dinners. Unfortunately, this remains the longest-impacted industry of the Governor's closure orders. While we hope these orders are short-lived, these establishments need help now to survive. I along with my House Democratic colleagues have proposed a package of bills that would provide grants to local restaurants, bars and clubs, reduce and eliminate specific licensing fees, extend discounts to licensees and protect businesses by quaranteeing their insurance pays out in future emergencies.

Fire, Rescue, and EMS Company Grants

I was proud to support a \$50 million grant program, signed into law as Act 26, that will provide some much-needed financial assistance to fire, rescue and EMS companies that have found it difficult to keep their operations running due to COVID-19. The men and women who dedicate themselves to public safety in our communities deserve our unending support and appreciation, and it is my hope that this program will help to bridge the gap so many companies are facing through these challenging times.

STATE FUNDING SUPPORTS LOCAL JOBS, OPPORTUNITY AND INFRASTRUCTURE

New Manufacturing Facility to Bring 400 Jobs to Olyphant

Last month, CANPACK Group, a global manufacturer of aluminum cans and glass bottles, announced it will continue its expansion by building a new 908,000-square-foot facility in Olyphant at the former Cinram site. The company has pledged to invest nearly \$366 million into the project and will create more than 400 executive, professional and technical manufacturing jobs within three years.

I know a great number of constituents, including relatives of mine, remember with fondness their family-sustaining employment at the former Specialty Records/Cinram facility and we all look forward to a major employer returning to that site. Now more than ever in light of COVID-19's impact, our region needed some good news, and I am proud that CANPACK saw such value not just in the prospective site, but most importantly in our extraordinary local workforce that will fill those good-paying jobs.

I was proud to join state Sen. John Blake in advocating to Gov. Tom Wolf for the investment of \$6 million toward the project via the Redevelopment Assistance Capital Program, and I applaud all local officials for recognizing the critical role public-private partnerships like this must play in our local economy.

Scranton Bridge Replacement

Last month, I was pleased to announce that the City of Scranton would receive more than \$1 million in Multimodal Program grant funding to replace the Ash Street Bridge, improving the overall safety of pedestrians and motorists who travel that road every day for work, medical appointments or daily errands.

This is a critical infrastructure project in the 112th District as the heavily used Ash Street Bridge is showing its age, wear and tear. The city of Scranton – like so many other communities across the state – is facing serious, ongoing financial challenges. So, this grant funding will go a long way to ensure an important infrastructure asset is being properly maintained and improved without diverting significant resources from the city's budget.

Frontline Worker Hazard Pay

Our frontline workers have always been the backbone of our economy, but for so many it was not until the outbreak of COVID-19 that their health and safety were put at risk simply by going to work. These



workers continue to carry us through this incredibly difficult time, providing us with life-sustaining goods and services. I applaud the Governor for establishing a \$50 million grant program to provide hazard pay to some of the most at-risk professions. However, we must dedicate greater funding and significantly expand the list of eligible workers – an effort I am proud to be committed to in the Pennsylvania House of Representatives.




Helping the Homebound

The colored paper was designed to alert neighbors and volunteers in the program that a participant was in need.

The COVID-19 pandemic has shown that our most vulnerable loved ones and neighbors need our help. These are people who are at high-risk of contracting coronavirus if they leave their homes. Whether it's a run to the grocery store or the pharmacy, or a simple phone call to ensure their safety, Helping the Homebound provides assistance along with comfort and peace of mind for our elderly neighbors.
