As you may have heard, the boundaries of the Second Legislative District are changing based on the recent redistricting that occurred following the U.S. Census. To the right is a map of the new district lines.

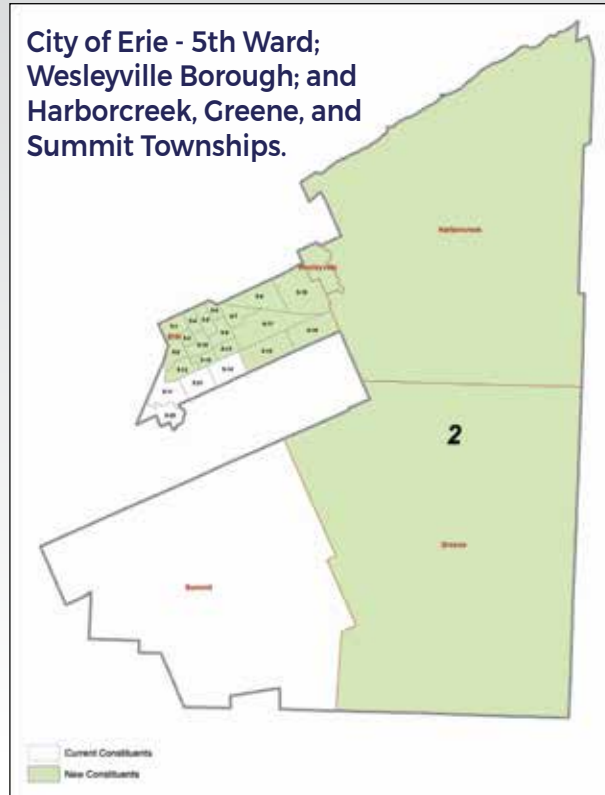

## SUPPORTING OUR SCHOOLS

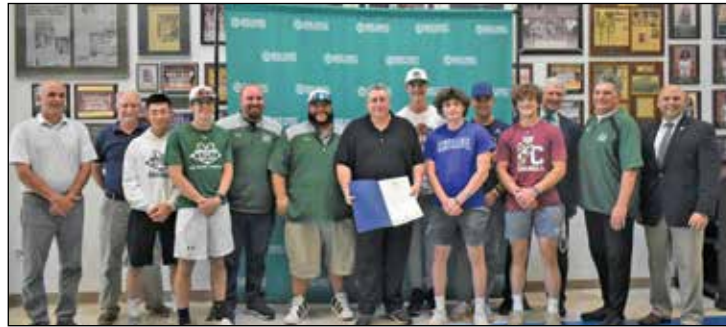

# BRINGING YOUR TAX DOLLARS BACK TO THE DISTRICT

One of my most important jobs as your representative is bringing your tax dollars back home to the district. So far this year, I have worked to help secure more than \$27 million, including:

- **More than \$8.3 million** to help stabilize Erie child care centers.
- **Nearly \$8 million** for projects to boost regional economic development and business growth, including funding for development of the former Erie Malleable Iron plant into a high-tech business park, among other projects.
- **Nearly \$4 million** for infrastructure improvements and community programs, including projects to upgrade traffic intersections, fund recycling projects, repair docks and improve fishing opportunities, upgrade the Blasco Memorial Library, and create a workforce training center, among other projects.
- **More than \$3 million** to bolster early education programs.
- **More than \$1.5 million** to fight crime, improve probation services, strengthen services for sexual assault victims, better equip our first responders, and respond to student mental health needs.
- **Nearly \$1 million** to expand housing-related services for families in need.
- **\$1 million** total in Ready to Learn Block Grant funding to the Erie City School District, Iroquois School District, and Harbor Creek School District.
- **More than \$350,000** to bolster resources and training for our first responders.

## Funding for District 2 schools will increase by

### Basic Education Funding

Erie City - 17.9%  
Harbor Creek - 4.8%  
Fort LeBoeuf - 4.6%  
Iroquois - 10%  
Wattsburg Area - 7.3%

### Special Education Funding

Erie City - 11.6%  
Harbor Creek - 14.6%  
For LeBoeuf - 6.2%  
Iroquois - 12.4%  
Wattsburg Area - 7.8%

Additionally, each school district will receive **\$100,000 + \$15** for each student from a **\$100 million** fund for school safety and mental health.



## NEW FIREWORKS LAW ALLOWS MUNICIPALITIES TO RESTRICT USE

There are some commonsense restrictions now in place for consumer fireworks use.

Under the new law, municipalities will have the authority to restrict the use of fireworks between 10 p.m. and 10 a.m., except during July 2-4 and on Dec. 31, when they can be used until 1 a.m. the following morning. (Fireworks will also be permitted over the Memorial and Labor Day weekends.)

There will also be enhanced penalties for improper sales or illegal use.

Most importantly, the new law gives local governments the power to ban fireworks in situations where they cannot be used in compliance with existing rules, including those prohibiting their use within 150 feet of buildings.

# SERVING OUR SENIORS

**Seniors: I want to make sure you are aware of these programs and services, including some that are new for this year.**

## PROPERTY TAX/RENT REBATE BONUS

Residents who qualify for rebates on property taxes or rent paid in 2021 will see a one-time bonus rebate under the Property Tax/Rent Rebate Program. The bonus rebate will equal 70% of an applicant's regular rebate. For example, an applicant who received a regular rebate of \$500 can expect to see a bonus rebate of \$350.

Applicants who have already filed for or received their regular rebate do not need to do anything to receive the bonus rebate, which will be sent via the same method – direct deposit or check – used to deliver the regular rebate.

Please note: if you have not yet filed for your standard rebate, the deadline has been extended to **Dec. 31**. You can apply online by visiting [www.revenue.pa.gov](http://www.revenue.pa.gov) and scrolling down to the "My Path" link – or contact my office for help applying!

## SENIOR FOOD BOX PROGRAM

Second Harvest Food Bank of Northwest Pennsylvania is the local distributor for this U.S. Department of Agriculture program, which provides eligible seniors with

boxes of nutritious, nonperishable food items to supplement their household purchases. Applicants must be at least 60 or older and fall within certain income guidelines.

This is a reminder that seniors can stop into our office, apply for an EMTA senior bus pass, and receive the pass all in one visit! Please remember to bring valid proof of age!

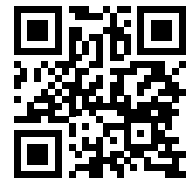
## PRESCRIPTION ASSISTANCE EXPANDED

# MERSKI EMBRACES LEADERSHIP ROLE

## A TAX CREDIT TO HELP WORKING PARENTS

Working parents and guardians will soon be able to claim a child care tax credit on their PA state taxes under a new program created in the 2022-23 state budget.

The state program is modeled after the existing federal child care tax credit program and benefits working families with children in daycare who already qualify for the federal program. The state credit is for 30% of the federally approved expense.

Under the state program – expected to benefit more than 220,000 families – filers in households earning more than \$43,000 could be eligible for \$180 (for one child) or \$360 (for two or more children), while filers in households earning less than \$43,000 could be eligible for \$315 (for one child) or \$630 (for two or more children).

Parents and guardians will be able to claim the state credit beginning in 2023.

## STATE PROGRAM CAN PROVIDE MORTGAGE HELP

This is a reminder that residents who are behind on their mortgage because of pandemic-related hardship may be eligible for the **Pennsylvania Homeowner Assistance Fund**. The program can provide eligible households with up to \$30,000 in assistance, including mortgage reinstatement, forward mortgage payment, property charges, and delinquent utilities.

The program is available to residents who have a household income equal to or less than 150% of the area median household income and who meet several other requirements.
