Public Input Hearings Scheduled on Proposed Rate Increase Requests by Community Utilities of Pennsylvania Inc. (CUPA)

Docket Nos. R-2023-3042804 (water), R-2023-304805 (wastewater)



Did you know?

On November 9, 2023, Community Utilities of Pennsylvania Inc. (CUPA) asked the Pennsylvania Public Utility Commission (PUC) to increase rates for its customers. If the rate increase request is granted, CUPA can collect an additional \$1,449,638 million per year from its customers. This would mean customers will be paying more than they ever have before.

How would this impact me?

If the company's proposal is approved:

- The fixed monthly customer charge, a charge paid no matter how much or little a consumer uses, would increase by 29% to 36% for all residential water customers.
- The total monthly water bill for a residential customer in Tamiment using 2,270 gallons would increase by 69%.
- A residential customer in the Penn Estates and Utilities Inc. service areas using 3,400 gallons per month would see wastewater bills increase by 51%.

Your total monthly bill increase will depend on how much you use and your service location.

Who is the OCA?

The Office of Consumer Advocate (OCA) represents Pennsylvania utility consumers and advocates for each consumer's right to reliable, safe and affordable utility service.

What will we do?

During the next several months, the OCA will fully participate in this case to represent the interests of consumers. We will review the case for fairness of the proposed increases and new charges. This is done with help from expert witnesses and public participation.
