New state budget has few bright spots

Despite a few spending increases, Rep. Bizzarro says the state's new \$28.4 billion budget plan is a measure of mediocrity, offering very little to address Pennsylvania's most pressing problems like education and economic development.

"The 2013-14 budget fails to find solutions and reinforces poor policy decisions of the past," Rep. Bizzarro said. "It is inconsiderate of both job creation and retention within the state. Pennsylvania is rated near the bottom on such efforts, and the spending plan does little to change dismal unemployment and economic development numbers."

Lack of economic development initiatives

The state budget offers few opportunities to address pending economic development downturns like those currently faced in Erie County. In Harrisburg, the Erie delegation emphasized the looming GE Transportation layoffs at the Lawrence Park locomotive plants, including the

statewide repercussions of such a loss to the area.

"The delegation is committed to seeking alternatives to job furloughs and work transfers," Rep. Bizzarro said. "However, it will be difficult without the needed investment in human capital."

Rep. Bizzarro is urging his colleagues on the other side of the aisle to stop focusing on providing deep tax cuts to a privileged few. Instead, he is encouraging them to find new routes to job growth and retention in local communities and in the commonwealth.

Dismal school funding

The budget also continues underfunding of local school districts. Only nine states contribute a lower percentage of state education funding than Pennsylvania.

Failing to provide the state funding needed to maintain a "thorough and efficient" education system puts the fiscal burden on the backs of property taxpayers. This is unfair to the hardworking, middle-class families in Erie County and across the state.

"I was not yet elected and serving in the House of Representatives when nearly

\$1 billion was cut from the education budget two years ago," Rep. Bizzarro noted. "The new state budget would restore too little to begin undoing the harm caused by these cuts.

"As a former administrative employee in one of our local districts, I know all too well how this cut in funding will affect the key asset to a strong future — Pennsylvania students."

The chart below, which includes the education subsidies in the new state budget, demonstrates the cuts since the 2010-11 school year:

Bright spots

HEALTH: The budget restores funding for diabetes programs, biotechnology research, epilepsy support services, lupus programs, regional poison control centers, traumacoordination and Tourette syndrome programs, and amyotrophic lateral sclerosis (ALS) support services, which would have been eliminated in the governor's original proposal.

The budget also includes \$19.9 million to provide community waiver services for 1,180 intellectually disabled citizens in 2013-14, including 380 people on waiting lists.

STATE POLICE: The budget also provides \$210 million for the state troopers, an increase of \$15 million or 7.6 percent. This will allow the state police to hire 290 cadets, as more than 1,200 state troopers become eligible to retire this summer.

SENIOR PROGRAMS: The commonwealth can thank its successful Pennsylvania Lottery for a record investment in programs for older state residents in the 2013-14 spending plan.

The budget provides more than \$50 million in additional funding for senior programs, including:

- \$49 million to expand home- and community-based services for 4,528 elderly and disabled Pennsylvanians;
- \$2 million in grants to senior centers to modernize facilities and programs; and
- \$5 million in enhanced support to Area Agencies on Aging.

Missed Opportunities

MEDICAID EXPANSION: Rep. Bizzarro said that Gov. Corbett and his allies continue to balk at expanding Medicaid, even though more than half the states — including many Republican governors — have seen the wisdom in doing so.

One day after the budget was signed, a provision that would expand Medicaid was destroyed despite bipartisan support for it. This will hurt Pennsylvanians and many families in Erie County.

"Medicaid expansion would provide more than half a million Pennsylvanians with health care — including 30,000 veterans — and would create 40,000 good-paying jobs," Rep. Bizzarro said. "Denying Medicaid expansion also will cost us existing jobs at hospitals across the state that are struggling with the cost of uncompensated care."

The purpose of Medicaid is to provide health insurance coverage to low-income families and individuals, including children, parents, pregnant women, people with disabilities and senior citizens. Those who could potentially qualify for Medicaid coverage under expansion would be relatives, friends or neighbors.

"One of the largest beneficiaries of expansion would be seniors," Rep. Bizzarro said. "They deserve the ability to live their retirements out fully and with the dignity that Medicaid expansion would provide."

The federal government would cover 100 percent of Pennsylvania's cost for the first three years and gradually reduce to 90 percent after that.

TRANSPORTATION: A plan to adequately and fairly fund Pennsylvania's transportation infrastructure — our roads and bridges — and mass transit never gelled during the budget process.

"Fortunately, a plan that never had any substantial bipartisan support was detoured in the House," Rep. Bizzarro said. "Transportation funding will be revisited in the fall, and I will continue to work in a bipartisan fashion to pass a proposal that addresses the needs of the 3rd Legislative District and all of Pennsylvania."

Misguided Priorities

LIQUOR PRIVATIZATION: Gov. Corbett attempted to tie passage of the budget to privatization of the liquor stores but was unable to garner sufficient support.

Rep. Bizzarro supports modernizing the state liquor system, and not the outright sale of a proven revenue producer.

"Pennsylvania's liquor stores provided a record \$560 million to state coffers and local entities in the last fiscal year," Rep. Bizzarro said. "We can modernize the sale of spirits without devastating an important state asset whose components include hundreds of small businesses."

This issue also could be revisited in the fall.

LOTTERY PRIVATIZATION: A last-minute effort by the governor during the budget process to privatize our Pennsylvania Lottery fell through.

"The attention given to the privatization scheme

detracted from attention to the budget," Rep. Bizzarro said. "Little support exists for selling the operations of the lottery, which consistently provides more than \$1 billion yearly to benefit seniors through programs like long-term care, pharmaceutical assistance, caregiver support, shared rides, free transit rides, and property tax and rent rebates."

The lottery recently posted another record-breaking year, finishing the fiscal year with nearly \$3.7 billion in sales, resulting in more than \$1 billion net profit that is used to fund programs for senior citizens.

"Unfortunately, after the budget was passed, the governor announced two contract extensions, enabling him to continue working toward his goal of privatizing the lottery by selling it to a British firm," Rep. Bizzarro said. "The lottery will have to pay \$3.5 million in consultant fees linked to the privatization effort, and that's wasted money that could have benefitted our older residents."

Veterans' Corner

Pennsylvania vehicle owners can show their support of veterans with the new "Honoring Our Veterans" license plate available through PennDOT.

The plate features images of the American flag and a bald eagle with the words "Honoring Our Veterans."

The plate is available for cars and light trucks. It costs \$35, and \$15 from each sale goes to the Veterans

Trust Fund, which provides grants to veterans' service organizations and other

organizations assisting Pennsylvania veterans.

Please call or stop by the office for a form to obtain the new plate or for help with any other PennDOT driver or vehicle service.



Earlier this year, Rep. Bizzarro helped pass <u>House Bill 159</u>, which, if passed by the Senate, would establish the Veterans First Tax Credit for small businesses.

"The measure would provide a \$4,000-a-year tax credit to businesses with less than 100 employees to hire veterans who are currently unemployed," Rep. Bizzarro said. "The bill is expected to create 12,500 jobs for state veterans who have been out of work for more than six months."

See you at 'Light the Night'

As many of you know, Rep. Bizzarro was treated for leukemia at a very early age.

"I am thankful every day for the research that saved my life," he said. "Sharing my story has connected me with many survivors, their family members and friends who also have been touched by this disease."

In June, the state House of Representatives unanimously approved Rep. Bizzarro's House Resolution 403 to spotlight support for leukemia and lymphoma research. The resolution urges participation in the 200 Light the Night walks scheduled across the nation in September and October, including 12 in Pennsylvania.

"I am honored that September 2013 has officially been recognized as "Light the Night Walk Month" in Pennsylvania," Rep. Bizzarro said. "It spotlights the great work and research being done to cure leukemia."

Rep. Bizzarro also is very pleased to be honorary chairperson for Erie's Light the Night walk, scheduled for Sept. 19 at Jerry Uht Park.

Last year's Light the Night event in Erie attracted 700 walkers and raised more than \$112,000 for research. The walk culminates weeks of spirited fundraising by teams and individuals dedicated to raising money for cancer research through the Leukemia and Lymphoma Society.

Rep. Bizzarro commends his colleagues for their support of this great initiative and encourages you to be a part of a great event.

How Does Redistricting Affect You?



The current 3rd Legislative District

The Pennsylvania Supreme Court earlier this year upheld a redistricting plan that redraws the boundaries of all 203 state House and all 50 state Senate districts.

The plan moves the 5th Legislative District, currently represented by state Rep. Greg Lucas, east to Berks County. Rep. Lucas will remain the representative for the current 5th District until after the November 2014 election. At that time, portions of the current 5th District will be divided among the 3rd, 4th and 6th Legislative Districts.

Rep. Bizzarro currently represents the 3rd District.

The new 3rd District will consist of McKean and Washington townships, Edinboro and McKean boroughs, as well as Districts 2 through 24 in Millcreek Township, with the exception of District 21.

Again, these changes do not take effect until December

2014.

Fairview Township – currently in the 3rd District – will move to the 6th District. Waterford Borough and Waterford Township – currently in the 3rd District – will move to the 4th Legislative District.

These changes do not affect your township or school district affiliation.

The process of redrawing the boundaries of Pennsylvania's House and Senate districts takes place every 10 years following the Census. It is done by the Legislative Reapportionment Commission to equalize populations in legislative districts.
