Deasy calling for credit card law reforms

In light of recent corporate security breaches that have compromised the personal information of millions of Americans, I have introduced a concurrent resolution urging congressional reform of federal credit card laws.

Recently, a resident's card number was hacked. The card was not lost or stolen but somehow a criminal obtained access to the number. The thief then created a fraudulent card and used it to make over \$1,200 in unauthorized purchases. Video surveillance of the perpetrator showed that when a debit transaction failed, the purchase went through as a credit transaction. The purchases were approved without the criminal ever having to show identification, even after the purchase was initially rejected. This is a flawed system that needs drastic reform to better protect consumers.

My resolution would call on Congress to enact reforms that would require modifications to link photo identification with all debit and credit card purchases. Transactions where photo identification does not match the payment card would be denied and reported to the issuing card agency. Banking or credit card companies would be required to notify the consumer of any attempts of fraudulent charges.

This change is needed to protect consumers. Millions of people across the nation have been harmed by identity theft. At a time when many live on a tight budget and are struggling financially, people simply cannot afford to go through such a drastic inconvenience.

There are resources available to help you if you become a victim of fraud. You should first contact the three main credit reporting companies and give notice of fraudulent activity.

You should then close the accounts that you know or believe have been fraudulently accessed and file a police report with your local authorities or in the region the theft took place.

This is an alarming statistic. New law will protect nearly 50,000 seniors' prescription drug coverage

Change in income exemption will aid an additional 10,000 seniors

House Bill 777 passed the General Assembly unanimously and was signed into law on Feb. 7, 2014. This bill maintains eligibility for Pennsylvania seniors in PACE/PACENET whose Social Security COLA adjustment pushes them over the prescription drug benefit income limit.

Under the new law, residents cannot be disqualified from PACE/PACENET based on income increases from Social Security COLAs, regardless of whether the resultant higher incomes are above the eligibility thresholds. The exemption, which expired in December, has been extended through Dec. 31, 2015.

PACE and PACENET subsidize low-cost medications for low-income state residents older than 65. Funding for the programs comes from the state lottery fund.

The new law doesn't just temporarily extend the COLA moratorium. The law makes certain income exempt from counting toward eligibility requirements for the programs permanently.

Before the new law, Social Security income used to pay premiums for Medicare Part B coverage was counted as income for purposes of determining program eligibility. These payments will now be excluded when determining income with regards to PACE and PACENET qualification.

Like many private insurance premiums that are deducted directly from a paycheck, Medicare Part B premiums are automatically deducted from Social Security checks.

According to the Pennsylvania Department of Aging, nearly 10,000 seniors would qualify for PACE and PACENET if their Medicare Part B premium would be excluded from the current definition of income in the PACE law. The average Medicare Part B benefit is approximately \$106 per-month, or \$1,200 per year.

Does the state have your unclaimed property?

Every year, the state Treasurer's Office obtains millions of dollars in unclaimed property. This property includes any financial asset that has been left with a bank, insurance company or business or organization without any activity for five years.

Those entities are required by law to transfer abandoned property to the state Treasurer's Office, which maintains custody of the property until it is claimed by the owner. The office maintains a list of Pennsylvanians who belong to that property, and you may be on that list!

Unclaimed property may include:

- Closed bank accounts;
- Uncashed checks, including paychecks;
- Lost stocks and bonds;
- Contents of safe deposit boxes;
- Proceeds from the demutualization of insurance companies; and
- Expired gift cards/gift certificates.

It is estimated that nearly 10 percent of Pennsylvanians have unclaimed property.



To find out if you have unclaimed property, search your name and the names of your friends and family in the Unclaimed Property database at www.patreasury.gov/Unclaimed or call 1-800-222-2046. There is **NO CHARGE** to claim your unclaimed property.

KEY *Legislation*



Each session, the House considers hundreds, if not thousands, of pieces of legislation that are drafted to improve the quality of life in Pennsylvania. I am honored to co-sponsor the following legislation that will best benefit the residents of our commonwealth and ensure the safety, well-being and prosperity of our future:

House Bill 1800

I am a proud co-sponsor of legislation that would establish a new “Made in PA” logo to include a broader range of products made in Pennsylvania that are not covered by the blue and gold PA Preferred label. The program, which would be administered by the Pennsylvania Department of Community and Economic Development, would permit the use of a “Made in PA” trademark on products manufactured or produced in the commonwealth. In these tough economic times, I think it is vital that we urge Pennsylvania consumers to support Pennsylvania businesses by buying Pennsylvania manufactured and produced items. This effort will help maintain jobs and potentially facilitate job growth in our great commonwealth of Pennsylvania.

House Bill 2031

I am supporting legislation that would help Pennsylvania families by fortifying the tax-exempt status of property transfers made through living trusts. This legislation would clarify the requirements for a living trust to serve as a substitute will so families can continue to transfer property without having to pay the 1 percent realty transfer tax. Properties in Pennsylvania are taxed enough. Families should not suffer additional tax penalties when transferring property from a living trust.

House Bill 1504

I am co-sponsoring a bill that would help protect law enforcement as they protect us. This bill would require training for police officers and the minor judiciary to include instruction on how to recognize people with mental health conditions and intellectual disabilities, identify diversionary options for those suffering from mental health disorders, and perform search and seizure, arrest

and bail practices and procedures.

This bill has the potential to better equip police officers and minor judiciary with the resources needed to identify people suffering from mental health conditions at the earliest point in time and get these individuals the medical treatment they need.

House Bill 2204

I am co-sponsoring a bill that would be known as “Rocco’s Law.” Under this bill, the offenses for cruelty to police animals would become “aggravated” when a person willfully or maliciously tortures, mutilates, injures, disables, poisons or kills a police animal while the animal is in the performance of its duty and would be graded as a first-degree felony.

As you may be aware, Rocco – an 8-year-old German Shepherd canine officer with the City of Pittsburgh Bureau of Police – was fatally stabbed while apprehending a suspect. Under current law, such an offense would be graded as a third-degree felony. This legislation would ensure a more severe

penalty for criminal suspects who display such disregard toward law enforcement officers.

House Bill 41

In an effort to protect animals that cannot speak up for themselves, I am co-sponsoring legislation that would place restrictions on the tethering of dogs.

More specifically, the legislation would make it a summary offense to tether a dog outside and unattended to any stationary object by the use of a restraint between the hours of 10 p.m. and 6 a.m. A person convicted of this offense may be subject to forfeiture of the dog.

This legislation is in response to repeated complaints that the continuous confinement of dogs by a tether is inhumane. A tether significantly restricts a dog’s movement. A tether can also become tangled or hook on the dog’s structure or other objects, further restricting the dog’s movement and potentially causing injury.
