It's been a busy few months in Harrisburg. In recent weeks, my focus has been on working with my colleagues on a 2017-18 state budget that supports Pennsylvania families, small businesses and our communities. As your representative, I will continue to advocate for what works for all of us – adequately funded schools, jobs that pay livable wages and services that help our children, veterans and disabled residents.

One of the highlights of serving as your representative has been the chance to meet people living throughout the district. I've been able to recognize distinguished student

## Working on issues of importance to constituents

I've introduced and co-sponsored legislation on a variety of issues that impact people living in the 31st District. Here's a look at just a few of the initiatives:

### Working for a commuter tax credit

I've introduced legislation that would provide a tax break for commuters who use the Pennsylvania Turnpike and bridges across the Delaware River.

House Bill 926, which is similar to a bill introduced by my predecessor, former Rep. Steve Santarsiero, would offer an annual state income tax credit for those commuters of 50 percent of tolls paid, with a \$500 cap. Individuals, corporations and small businesses with tax liability would be eligible.

### Ending child marriage

Child marriage is an unfortunate reality in the United States and in our state. Pennsylvania is among 27 states that have no minimum marriage age.

Under current law, a marriage license can be issued for someone between the ages of 16 and 18 if a parent or guardian consents. A marriage license can be issued for someone even younger than that with court approval. It is time

to change that and protect children.

Research shows that marriage before the age of 18 is often coercive or exploitative and can have devastating, long-term effects on the child. We should make sure our children have the chance to be children.

House Bill 1038 would establish the minimum marriage age as 18 with no exceptions.

Other states are considering this step, too. The bill has been assigned to the House Judiciary Committee for consideration.

### Drawing legislative districts fairly

We in Pennsylvania need to make sure that our state legislative and congressional districts are mapped out fairly and not in a partisan manner.

Toward that end, I co-sponsored H.B. 722 to establish an Independent Redistricting Commission and provide a nonpartisan process for redistricting Pennsylvania's

# Planes, Trains and Automobiles

Developing and maintaining our infrastructure and transportation systems have always been key components of state government. Whether you drive, fly, ride the rails, or use other modes of transportation, this section focuses on moving around our great commonwealth and beyond.

## Good news for air travelers

The House and Senate voted for and Governor Tom Wolf signed Senate Bill 133 in May. Without action, Pennsylvanians would have needed federally approved ID, other than their PA driver's licenses, for air travel beginning Jan. 22, 2018.

This legislation will move Pennsylvania toward compliance with federal Real ID regulations to ensure that state residents don't face difficulty using their IDs for air travel or visits to federal facilities.

I'm pleased that the legislature worked cooperatively on a bipartisan, bicameral basis to find a solution on this issue. No one wants to encounter problems trying to travel by plane or enter federal buildings for work or other reasons.

Under this compromise bill, Pennsylvanians will not be forced to obtain a Real ID-compliant identification card. Instead, a two-tier system will allow the consumer to decide if he/she wants the current, standard PennDOT driver's license or identification card, or opt for the Real ID card.

## Oxford Valley Road and Reading Avenue to be repaved

Back in March, I toured the roads of the Yardley-Newtown-Morrisville area with PennDOT and local government representatives.

PennDOT just announced that it has awarded a contract for a much-needed repave of Oxford Valley Road/Reading Avenue between Edgewood Road and Main Street. It will be scheduled sometime between now and October.

Also on the tour, we discussed problem areas and short-term and long-term infrastructure goals in our area. We were joined by LMT Supervisors John Lewis and Judi Reiss, Yardley Council President Katherine Cadwallader and Borough Manager John Boyle, Newtown Township Public Works Director Joe Schiavoni, Morrisville Borough Council Member Corryn Kronnagel and, by telephone, Newtown Borough Council President Bob Walker.

Each of the municipal officials had the opportunity to direct PennDOT to the areas of greatest concern in each municipality. We will seek updates on the concerns we raised and will continue to work with PennDOT on roadway issues throughout the district.

## Trenton airport meeting

Also in May, I attended the Trenton-Mercer County Airport's second Master Plan meeting, with a goal of bringing attention to the impact of air traffic and noise upon our communities.

I was pleased to see a substantial number of Bucks County residents at the meeting. I spoke with residents concerned about noise generated by planes taking off and landing and with airport officials.

After the first meeting in October, and again after this meeting, I sent a letter to airport management asking for better notification of airport meetings for residents and government officials, additional public meetings in the Yardley/Lower Makefield area, as well as the addition of flight curfews and fines for violation of those curfews. I also asked that a formal environmental impact study be done for each construction project at the airport.

Those measures would go a long way in helping to alleviate the concerns in our community and make sure our residents are able to have a voice in the Master Plan process. I look forward to learning more about how the airport plans to mitigate noise with minimal impact upon the airport's day-to-day business.

## Yardley Train Station renovations chugging down the track

My office was recently briefed by SEPTA on the renovations to the Yardley Train Station. Phase I, which involved creating a new raised platform and demolishing the old one, is completed.

Phase II, which involves adding a handicap ramp, installing a new shelter, adding sidewalks, lights and repaving the parking lots is on pace to be finished by the end of the year.

## Paving the way for Yardley sidewalk project

On May 26, PennDOT issued a highway occupancy permit for Yardley to proceed with its project to build a sidewalk on the northbound side of North Main Street.

Construction is expected to begin on Phase I in the fall. Once both phases are completed, the sidewalk will extend from the Grist Mill parking lot to the Lower Makefield border at Dolington Road.

# New ABLÉ program offers help for disabled individuals and their families

I was proud to stand with Treasurer Joe Torsella when he announced the opening of Pennsylvania's new ABLÉ savings program on April 3.

The ABLÉ program, administered by the state Treasurer's Office, allows individuals with qualifying disabilities a tax-advantaged way to save or invest without losing their government benefits. This program helps relieve a source of concern for many disabled people and those who care for them, by allowing them to ensure they can both secure the benefits they need now and prepare for the future.

On April 1, I offered to the public an update on the ABLÉ program and other legislative issues affecting those with autism and intellectual disabilities. We also discussed CHIP, the Children's Health Insurance Program, Medical Assistance and other assistance programs available.

After the legislative briefing, the Newtown Theatre presented a

special "sensory-friendly" screening designed particularly for families with children with autism and intellectual disabilities.

It was heart-warming to see children be able to enjoy the film with their families in an environment that works for them. I'll keep working to make sure we at the state level are providing the services and assistance those individuals with disabilities need.

## Pension reform bill signed into law

I recently joined 142 of my colleagues in passing the first meaningful pension reform bill in seven years. This bipartisan, bicameral effort represents a big step toward ending the gridlock in Harrisburg, while supporting our schools and saving taxpayers money.

Senate Bill 1, which was signed into law by Gov. Wolf, represents the culmination of months of discussion and compromise between Democratic and Republican legislators.

I spent a great deal of time considering this bill and heard from many people before casting my vote. It was important to me that any reform bill ensure that we continue to pay down our pension debt and better protect taxpayers by shifting risk and reducing Wall Street fees. We need to

continue to provide state workers and teachers with a fair retirement benefit, while also providing long-term relief to our school districts. In addition to accomplishing these goals, this compromise bill protected the pensions of all current and former teachers and other public employees.

This bill, though not perfect, moves Pennsylvania forward. And, it shows that Republicans and Democrats can work together to find solutions to Pennsylvania's most-pressing issues.

state Senate, state House and U.S. House districts. The commission would be tasked with conducting an open, transparent process for the drawing of district boundary lines, making sure there are channels for public comment.

The bill has bipartisan support, and there is a similar bill in the Senate.

#### Commonsense gun legislation

Universal background checks for all firearm purchases are a commonsense measure that most Americans support.

House Bill 1400, which I co-sponsored, would require

universal background checks for firearm purchases, including purchases at a licensed gun show in Pennsylvania.

This is another effort that has bipartisan support. It's a step we can take to make our communities safer while still respecting citizens' Second Amendment rights.

I've also introduced legislation, H.B. 528, that would require Pennsylvania State Police to determine if someone is on the FBI's terrorist watch list before that person would be allowed to purchase a firearm.
