A Quick Note about My Office

This spring, my Allentown office moved. Still located on the first floor of 2030 W. Tilghman St., the office is now on the opposite side of the building. The phone number (610-821-5577) remains the same.

PTRR Deadline Extended

In 2016, more than 548,000 people claimed over \$234 million in Property Tax/Rent Rebates across Pennsylvania. In Lehigh County, more than 14,000 claims were filed for more than \$6.2 million in rebates. In 2016, my office helped people claim more than \$131,000 in rebates. While my office has helped residents apply for more than \$113,000 in rebates so far in 2017, eligible residents now have extra time to apply for the program that can put hundreds of dollars back into your pocket to offset property taxes or rent. The deadline was extended from June 30 to December 31, 2017.

The Property Tax/Rent Rebate Program is open to:

- Eligible seniors 65 or older;
- Widows and widowers 50 or older; and
- People with permanent disabilities 18 or older;

To qualify, applicants must earn less than \$35,000 per year (for homeowners) or \$15,000 per year (for renters) – and only HALF of Social Security or railroad retirement benefits count toward eligibility. Residents of assisted living facilities may be eligible if they reside in a facility which pays property taxes and meet the income limits for renters. If you're eligible – or you know someone who might be – my office can help you file the application and answer questions. Just stop by 2030 W. Unclaimed Property

One of my favorite things to do is telling people who live in the 132nd



Legislative District that they have Unclaimed Property being held by the Pennsylvania Treasury. Because 1 in 10 Pennsylvania residents has money being held by the Treasury, my staff and I actively search this database so we can help people claim what belongs to them.

This could be an old savings account, a forgotten paycheck or refund, a stock dividend or insurance claim. Since we began tracking this in 2013, my office has helped constituents claim over \$943,000 in money from the Treasury's Unclaimed Property database.

If you get a call or a letter in the mail from me or my office about Unclaimed Property, do not be alarmed. If you are concerned, give us a call. If you would like to search on your own, visit PaTreasury.gov.

Updates on Legislation

Redistricting Reform

When I look at the way the Lehigh Valley has been carved up, with state House districts running from Kutztown to Laurys Station and Lower Macungie to Walnuttown (Berk County) and the 15th Congressional District extending from Bethlehem to the border of Harrisburg, there is no doubt in my mind the abuse needs to end. The Independent Redistricting Commission is the best way to do this.

Pennsylvania's approach to redistricting legislative lines for Congress and the General Assembly is atrocious, leads to imbalanced districts and results in ideological policy. In 2016, I took the Independent Redistricting Pledge and in 2017, I joined more than 90 of my colleagues in signing on to bipartisan legislation that will allow the voters of Pennsylvania to amend the Pennsylvania Constitution and establish an Independent Redistricting Commission.

The commission would include four members who are registered voters of the largest two political parties, four members who are registered with the other largest two political parties, and three members who are unaffiliated or registered with a minority party. The commission would allow for no current or recently elected officials, candidates, party officials, their aides or spouse. All work would be done in public and the commission would be prohibited from considering prior election results, voter or party registration or the addresses of incumbents or any other individuals.

Fighting for Jobs: Manufacturing & Apprentice Grant Program

This June, I introduced the Manufacturing and Apprentice Grant Program Act. By 2020, Pennsylvania is forecasted to have a shortage of nearly 170,000 skilled workers. Many of these jobs will be in high-tech manufacturing jobs that pay good family sustaining wages. Those with apprenticeships will pay an average of \$60,000 a year. My legislation would help workers get the training and skills they need to get a leg up on these types of jobs.

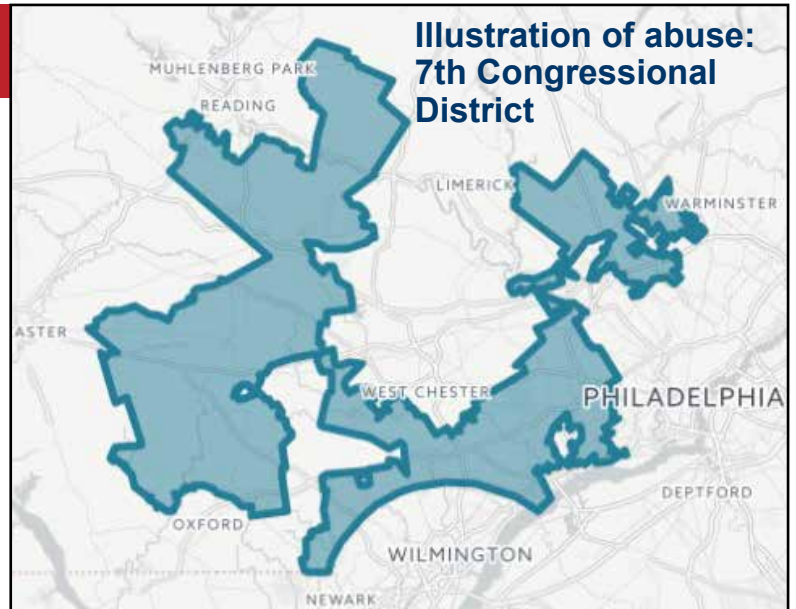

Families First: Strong Mom, Strong Baby

Postpartum depression poses a serious risk for the well-being of mothers and children. This is why I have been working with Representative Tarah Toohill (R) on the Strong Mom, Strong Baby legislation. Our bill would ensure infants and their mothers affected by postpartum depression have access to services currently available in communities across Pennsylvania through early intervention. Given what we know about the importance of the earliest years in childhood development, and a depressed mother's need for support, providing this support through the Early Intervention program will impact children and their families for a lifetime.

Aging in Place Tax Credits

Today, seniors are looking to live in their homes longer than was ever previously thought possible. While the cost of living independently at home can save between 72-74% when compared to residence in a nursing facility, there are often improvements that need to be made to the home or caregiver needs that arise. In January, I reintroduced legislation to offer tax credits that offset the costs of physical renovations and for caregiving services to make aging in place possible. This package of legislation would go a long way to help aging adults enjoy their independence.

Fighting for students

Budget for Allentown

The 2017-2018 budget has good news for the Allentown School District. For the upcoming school year, the state's commitment to Allentown will rise to \$125.2 million, marking a 30% increase in the state's support for our students since the 2012-2013 school year.

I am a strong believer that every child in Pennsylvania should have access to the world-class education necessary to live and thrive in the 21st century. For every dollar we invest in education now, we find savings and benefits in the future. It's important to remember that today's 5 year old will be a doctor in 25 years. Today's 3 year old will be somebody's teacher in my lifetime. The 2nd grader learning simple math will one day be asked to make medical or



scientific breakthroughs which save lives in our community and across the world. Our children will one day be called on to take care of us. While there are moral reasons to invest in our children today, I want the doctor screening my family for cancer, the teacher preparing my grandchildren and the scientist asked to save the world to have every tool and opportunity to succeed.

Charter School Reform

While I will always put our students first in the conversations about education, taxpayers deserve the truth. Recently, I was able to have legislation amended to prevent charter schools from advertising "free" tuition or transportation. Instead, any advertising would disclose that instructional and transportation costs are paid for by taxpayer dollars, much like the existing requirements for ads by state agencies.

Visit to LVCC

During the Week of the Young Child, Lehigh Valley Childcare invited me to visit its center at the Teen Parent Program at William Allen High School. Founded in 1981, this



facility provides access to reliable, affordable child care and early childhood education while offering a nurturing and structured infant/toddler program and the Raising a Reader initiative. I had a great time exploring and learning with the children.

2017 Pre-K Champions Award

It was a pleasure to visit the Cuddle Zone in Allentown with Senator Pat Browne and be recognized by Pre-K for PA with a 2017 Pre-K Champion's Award. While Pennsylvania has made tremendous progress in supporting early childhood education investments, we still have a long way to go; the 132nd District still needs 47 additional pre-k classrooms to meet the demand for high-quality pre-k education.



Trexler Students Visit Capitol

Thank you to the students from Trexler Middle School who came to the Capitol as part of the 2017 Student Technology Showcase. I was able to visit with them and learn about their award-winning project that included visits to local manufacturing facilities. These students showed incredibly hard work and talent. Update on Real ID

With the passage of Act 3, Pennsylvania finally will be able to offer drivers' licenses and photo identification which meets the standards of federal Real ID which became law in the aftermath of September 11th. No Pennsylvania resident will be required to get a REAL ID-compliant license or identification card, but residents who choose to do so will be able to use those forms of identification for air travel or entering a federal facility.

Currently, a Pennsylvania ID will allow you to travel by air and visit federal facilities. PennDOT estimates REAL ID-compliant driver licenses and identification cards will be available at the customer's option in 2019, allowing customers who want a REAL ID product to obtain one before the final DHS effective date of October 1, 2020.

Do you know everything you need to know about your Medicare coverage? If you join a private Medicare or prescription plan, your details could change and it could cost you. Medicare open enrollment begins on October 15 and ends December 7. Updates from PennDOT

Registration Forms Change

At the beginning of 2017, people renewing their car registration probably noticed a new form. The information requested is the same as in the past, but is now on the front and the back.

In addition to changes in the form, registrations renewed online will generate a new registration card immediately. Please print that registration card because PennDOT will no longer mail a new card

Many licensing and motor vehicle services are available online at www.dmv.pa.gov

when it is renewed online. Registration renewal discounts are still available for retirees earning less than \$19,200.

Reduced Registration for Retirees

If you are retired, receive Social Security and/or a pension (part time employment is permitted) and earn less than \$19,200 a year, instead of full registration price, you can pay \$10. One reduced annual registration fee is available per person. To learn if you are eligible or to file for your reduced registration, call me at 610-821-5577 or visit my Allentown office.

New Pennsylvania Licenses



Pennsylvania's driver's license and photo ID card designs are changing. The updated cards have features such as laser perforations and optically variable patterns, which will improve security and help prevent fraud. The old cards will be phased out over the next four years, so there is no need to replace current identification cards.
