Education, job training programs focus of new budget

The 2018-19 state budget shows a profound commitment to education and training people to find good jobs.

If we expect Pennsylvania schoolchildren to be able to compete in the worldwide marketplace, we must make them our top concern. I was glad to vote "yes" for this spending plan and support Gov. Tom Wolf's strong belief that all schoolchildren should receive adequate education funding regardless of their ZIP code.

It's important that we help our local school districts by providing more funding from the state level. While I would have liked to see more dollars pushed out to the schools, this \$100 million increase is a good step forward. By allocating additional money at the state level, it is our hope that local school districts will not need to lay off teachers, cut programs or raise property taxes.

Altogether, \$40 million is in the budget for PA Smart, the initiative proposed by Gov. Tom Wolf to boost workforce development, computer science and STEM training as follows:

 A \$30 million increase is in the career and technical education appropriation in the Department of Education. That includes \$10 million for the regular career and technical education subsidy and \$20 million for programs promoting employer engagement in postsecondary education, expanding computer science course offerings, developing STEM educator development and training programs, and advancing workers in career and technical fields.



- A new \$7 million apprenticeship training appropriation in the Department of Labor and Industry.
- A \$3 million increase in the industry partnerships appropriation in L&I.

As a member of the powerful House Appropriations Committee, I have the opportunity to hear firsthand from agency officials about how state programs are helping people across Pennsylvania.

This budget reflects House Democrats' priorities offered in our Plan4PA. We're pushing for quality schools, good jobs and fair taxes for all Pennsylvanians. In order to move the economy forward, we believe that working people and families deserve more from Harrisburg rather than the special interests.

Persian Gulf Veterans' Bonus Program deadline Aug. 31

I want to thank all of the veterans who have served and continue to serve our country so that we may enjoy the freedoms we have today as an independent nation.

To veterans of operations Desert Shield and Desert Storm, I want to point out that the deadline for the Persian Gulf Veterans' Bonus Program is Aug. 31, 2018.

Those who served on active duty between Aug. 2, 1990, and Aug. 31, 1991, may qualify for the bonus.

The program pays \$75 a month for qualifying, active-duty service members, up to a \$525 maximum. For those whose death was related to illness or injury received in the line of duty in the operations, an additional \$5,000 is available to the surviving family. Service members who were declared prisoners of war also may be eligible for an additional \$5,000.

The area will include several "learning stations" that will provide details of each war and conflict, as well as information on each of the branches of service.

The park will be located on the grounds of Memorial Stadium, adjacent to Scranton High School.

Property Tax/Rent Rebate deadline Dec. 31

The deadline to apply for the state Department of Revenue's Property Tax/Rent Rebate Program is Dec. 31. The maximum standard rebate is \$650, but supplemental rebates for qualifying homeowners can boost rebates up to \$975.

Eligibility requirements include: Pennsylvanians 65 or older, widows and widowers 50 or older, and people with disabilities 18 or older; an income limit of \$35,000 a year for homeowners and \$15,000 annually for renters, with half of Social Security income excluded; and spouses, personal representatives or estates may also file rebate claims on behalf of claimants who lived at least one day in 2017 and meet all other criteria.

Applications and FREE assistance are available from the Department of Revenue district offices, local Area Agencies on Aging, senior centers or at my Scranton office.
