Rep. Tina Davis hosted a public hearing on child custody issues at the Middletown Township Municipal Building.

The hearing focused on Rep. Davis' H.B. 956, which would update court procedures for child custody cases where there are allegations of domestic violence or child sexual abuse. Rep. Mark Rozzi's H.B. 2058, of which Davis is a cosponsor, also was discussed. That bill would implement standards to improve the courts' ability to respond to the impact of child abuse and domestic violence on victims, specifically children.
