PennDOT Emergency Contact

PennDOT offers you the ability to give law enforcement access to emergency contact information to reach someone who can speak for you if you are ever in a situation where you cannot speak for yourself. The information is stored in a secure database that is accessible only by law enforcement. You can choose two contacts.

Log-on to PennDOT.gov and click on the Upload Emergency Contact Information in the Travel and Safety section of the website or visit or call my office to get help.

Free credit reports

Your credit report can have an impact on employment and your ability to buy a home, car or even insurance.

Thanks to the Fair Credit Reporting Act, you can receive a free credit report from each of the three national credit reporting agencies (Equifax, Experian and TransUnion) every 12 months. You can order your report from all three agencies at the same time or spread those requests over the course of the year to better monitor your credit. These reports will not include your credit score.

News You Can Use

Property Tax and Rent Rebate

Every year, my office is busy helping hundreds of people file for a Property Tax and Rent Rebate. The best time to file is early in the tax season.

The Property Tax/Rent Rebate Program is open to:

- · Eligible seniors 65 or older.
- Widows and widowers 50 or older.
- People with permanent disabilities 18 or older.

To qualify, applicants must earn less than \$35,000 per year (for homeowners) or \$15,000 per year (for renters) – and only HALF of Social Security or railroad retirement benefits count toward eligibility. Residents of assisted living facilities may be eligible if they reside in a facility which pays property taxes and meets the income limits for renters. If you're eligible – or you know someone who might be - my office can help you file the application and answer questions. Just stop by my office in Allentown, or call 610-821-5577 and I will mail you the information.



Claim Your Money

One in 10 Pennsylvanians has money being held by the state Treasury. It could be an old savings account, a forgotten paycheck or refund, a stock dividend or an insurance claim. Helping people to claim what belongs to them has become one of my personal projects since taking



office in 2013. In total, we've helped constituents claim over \$1.2 million in money from the Treasury's unclaimed property database. That's money that has come back to your community.

You can check for your name by visiting PaTreasury.gov or by calling my office to have us check for you.

If you get a call or letter from me or my office with information about a claim in your name, it is not a scam. If you are unsure, call my office (610-821-5577) and we'll answer any of your questions or concerns.

Need a disability parking placard?

My office continues to help people obtain disability parking placards either by submitting their first application, requesting a replacement for one lost, damaged or stolen or by renewing a placard set to expire. Even if you don't have a car or driver's license, you can still have a disability placard for when somebody is taking you somewhere. Give my office a call (610-821-5577) and we will help determine the best way to get your request processed.

REAL ID

Pennsylvania's REAL ID roll out will take place throughout this spring, helping to prepare Pennsylvanians for full compliance in October 2020. This will be important, especially for people who plan to use their Pennsylvania license to board a commercial domestic airplane in the future. For more information about REAL ID, visit dmv.pa.gov/REALID. My office has resources and can answer your questions. Pennsylvania birth certificates

While preparing for REAL ID, it's possible you will need to obtain a copy of your birth certificate with a raised seal. My office is available to help submit your request for a Pennsylvania birth certificate and ensure proper delivery. Please call or visit my office to get this process started well in advance of when you need the birth certificate. The cost for a birth certificate is \$20 (free for veterans and their dependents).

News from Harrisburg

First responder mental health bill

We ask a lot from our first responders. They arrive at scenes of tragedy, often without regard to their personal safety. They comfort victims of crime and accidents, inform parents of the death of a child and save lives of people who were on death's door. We owe them a debt of gratitude and the assurance that we are looking out for their well-being. This includes helping to safeguard their mental health.



This is why I've teamed up with Rep. Frank Farry (R-Bucks) to introduce legislation creating peer-to-peer support groups for Pennsylvania's first responders. There is no reason for our heroes to encounter the horrors they experience without the support they deserve.

Suicide prevention law

Legislation I introduced to support suicide prevention and mental health services at colleges and universities in Pennsylvania was approved by the General Assembly and was signed by Gov. Tom Wolf in October. This legislation



would establish a certification process and standards for schools which elect to become a Certified Suicide Prevention Institution of Higher Education, allowing them to demonstrate their commitment to providing students with information and services to meet their mental health needs. There is no doubt in my mind this legislation will save lives in Pennsylvania.

Red Means Stop: A victory for grassroots leaders

Clark came to my office to share her concerns about motorists running stop signs when school



buses were stopped. She was prepared, organized and eager to advocate for this safety concern by allowing school districts to mount cameras on the arms that extend in front of the school bus when the stop sign is extended. Working with Sen. Pat Browne, we were able to introduce legislation supported by PennDOT, law enforcement and school officials. With her daughter Olivia, Amber rallied friends in advocacy work to build support for this legislation.

In October, this legislation passed the Senate and House and then was signed into law by Gov. Wolf. Amber, Olivia and A LOT of friends were there for the signing. This was a good example of how democracy is supposed to work. I'm honored to have worked with Amber and Sen. Browne to get this done.

Kaleb's resolution

In 2016, Kaleb was diagnosed with Adrenoleukodystrophy (ALD), a deadly genetic condition. He was named Lehigh County Deputy Sheriff for a day and his mom had undertaken an effort to raise awareness of the disease, the importance of newborn testing and the need for people to register for bone marrow donations to save lives. Kaleb's family knew each morning it was possible that a part of Kaleb — his laughter, hearing, language or respiratory skills — could be gone. That fear has since come to fruition.

As a result of a resolution I introduced. November was designated ALD Awareness Month. In October, Kaleb's family was on-hand as I shared their story in the House chamber.

We owe a deep gratitude to Kaleb and his family as they continue to raise awareness of ALD.



Clean slate goes into effect

In 2018, Gov. Wolf signed into law bipartisan legislation to include more offenses which can be sealed by filing



petitions through the courts. The law, which went into effect on Jan. 1. also creates an automated computer process to seal arrests that did not result in convictions within 60 days and summary offenses after 10 years. There is no doubt this process will help people who have paid their debts to society and worked to move forward with their lives.

Recognizing the process of petitioning the courts can be a challenge, Pennsylvania worked with Community Legal Services to establish "My Clean Slate," a program to provide information and consultations. Information about My Clean Slate is available at https://clsphila.org/mycleanslatepa.
