

POLICY HIGHLIGHTS

I introduced legislation that aims to equalize our agriculture industry and public school funding; ensure fair wages for all workers, and guarantee true environmental justice!

Fair Funding

As state legislators, we have a constitutional obligation to properly fund our public schools, but our state's current school model unfairly sets our young people up to fail. Despite the Basic Education Funding Commission unanimously agreeing in 2015 to deliver 100% of state funding to public schools through the fair funding formula it developed, four years later our schools still only receive 9% of state funding through that formula. When income and zip code are considered, this percentage of funding drastically decreases for many public schools in areas across our commonwealth, like Philadelphia. It's time to end the educational apartheid systemic in our system!

I introduced legislation, H.B. 961, that would require 100% of state funds for public schools to be immediately distributed through the fair funding formula. It also acknowledges that significantly more funding is required to ensure each school district has enough resources to educate its students.

To garner momentum for immediate enactment, I hosted a press conference on the 65th anniversary of the *Brown v. Board of Education* landmark decision, in front of the Franklin S. Edmonds Elementary School to discuss the disparities that still exist in the way Pennsylvania funds public schools.

100% Renewable Energy

According to recent national reports, Pennsylvania ranked 42nd in the total number of states producing the most renewable energy. Despite ranking as the third highest state nationwide in generating electricity, only 4.3% of our electricity is generated by renewables, particularly wind power; ultimately placing us as the 25th lowest state with a 10-year growth in renewable energy.

Ensuring that our commonwealth converts to 100% renewable energy by 2050, I introduced H.B. 2132 that would establish a Clean Energy Transition Task Force, a Clean Energy Center of Excellence, and a Council for Clean Energy Workforce Development. The entities would be tasked with evaluating current pollution-related issues affecting the commonwealth and its residents while also working toward maximizing the environmental and economic benefits of developing the state's renewable energy industry.

The renewable energy industry is not only better for our climate and environment, but it is proven that it is also better for our economy. The renewable energy industry is more labor-intensive, harnessing a newly skilled workforce, giving academic institutions the opportunity to advance new fields of technology as they educate a new generation of Pennsylvania's technology-based workforce. Therefore, more jobs are created for each unit of electricity generated from renewable sources than from fossil fuels.

One Fair Wage

Pennsylvania's minimum wage has remained frozen at \$7.25 since 2009 and is the lowest when, compared to neighboring Delaware (\$8.25), New York (\$10.00) and New Jersey (\$8.60). Incredibly, the federal wage level, enacted in 2007, forced our state to raise the minimum wage from \$7.15 to \$7.25.

More than 40% of the workforce working minimum wage jobs are adults. Coupled with the low tipped wage, our meager minimum wage has led to a system that promotes unfair pay, which disproportionately affects women and people of color. Additionally, a tipped wage system promotes the exploitation of workers.

To ensure our entire workforce can adequately provide for their families, I co-introduced a bill to raise the minimum wage to \$12 per hour and continue to increase each year until it reaches \$15 per hour and tied to the consumer price index. In addition, this bill would set the tipped wage to the same level - ensuring all workers get paid a living wage.

The bill would also make these important changes:

- Allow municipalities to create their own wage ordinances.
- Guard against wage theft by having the Department of Labor & Industry recover wages and penalties for all violations of the act, not just when a complaint is filed.
- Increase monetary penalties for violations, which in some cases have not been updated since 1968.
- Bring enforcement in line with the Federal Fair Labor Standards Act by allowing workers to receive damages, and unpaid wages.
- Requiring the Department of Human Services to calculate and publish the impact of a minimum wage increase on its programs, and mandate that savings be used to increase childcare and home and community-based services to ensure that these providers can pay the increased minimum wage.

Crop Grant Program Bill

Our commonwealth has been a strong contender in producing valuable commodities like hemp, hops, honey and hardwood, but these crops are not eligible for the federal Speciality Crop Block Grant program. I was proud to introduce H.B. 1519, a bipartisan, first-of-its-kind legislation that establishes a state level grant program to encourage farming of high-priority crops, ultimately allowing Pennsylvania to reconnect to its history of being a longtime leader in cultivating them and making access attainable for all.

My bill, which was signed into law by Gov. Tom Wolf, complements the federal Specialty Crop Block Grant Program by awarding grants for small producers and sets aside 10% of grant funds for successful applicants from rural and urban communities that have at least 20% poverty for at a minimum of 30 years. This bill equalizes the agriculture industry by removing barriers to entry and cultivating future generations of leaders in historically economically distressed regions.
