### Appointment to Gov. Wolf's Special Council on Gun Violence

In early December, I was appointed to join Governor Tom Wolf's Special Council on Gun Violence. I immediately began my tenure by participating in a regional hearing with the Special Council on Dec. 5 at Temple University in Philadelphia.

The Special Council was created as part of Wolf's executive order signed in August and is tasked with studying and making recommendations to prevent and reduce gun violence.

I'm honored by the appointment, and I take very

seriously the epidemic of gun violence in our commonwealth. I've already been hard at work bringing well-needed resources to the City of Chester, and I'm grateful for the opportunity to expand that work statewide. I also will continue to participate in the vital conversation over how we significantly reduce gun violence in Pennsylvania.

This appointment fits with my committee and caucus assignments with the Pennsylvania House of Representatives, which include the Children & Youth, Urban Affairs, Gaming and Tourism Committees and the PA SAFE Caucus.



#### Dear Neighbor,

We just reached the midpoint of my second term representing all of you in the 159th Legislative District as a state representative. It remains my distinct pleasure and honor to serve the fine folks of Chester, Chester Township, Eddystone, Lower Chichester, Marcus Hook, Parkside, Trainer, Upland and parts of Ridley and Upper Chichester.

Whether here at home in Delaware County or out in Harrisburg at the State Capitol, I am doing my best to work for you and improve the everyday lives of residents in the 159th and across the commonwealth.

In 2019, that meant a variety of legislation and events, a lot of which you can learn about in this annual Year in Review newsletter.

I've introduced legislation such as H.B. 738, which would require identification for purchase of firearm ammunition, and H.B. 740, which would ban sales of

"realistic" toy guns to children without an adult present.

Just this winter, I was appointed to join Governor Tom Wolf's Special Council on Gun Violence. Wolf created the council this summer to study and make recommendations that will help reduce gun violence in Pennsylvania.

I also introduced H.B. 1967, which would require health care providers to supply, without charge, a copy of medical charts and records to veterans who are homeless, and H.B. 1182, which would require landlords to allow early termination of a lease, without penalty, for tenants who move into facilities to receive hospice or palliative care.

Closer to home, I've hosted events and activities such as my Community Resource Fair, World Cancer Day, a financial seminar, expos for seniors and for children, a Karaoke and Family Resource Night, and my Across Colors Cultural Festival.

The 159th has also benefited from various grants that improve schools, infrastructure and the environment, as I and my House Democratic colleagues continue to push our Plan4PA, which puts people first. We're fighting for good jobs, affordable health care, quality schools, a cleaner environment, election reform and a fair economy.




#### Saluting real heroes

## Financial assistance for home heating available

The Low-Income Home Energy Assistance Program is available for low-income families and individuals who need help staying warm this winter.

LIHEAP offers cash grants of \$200 to \$1,000 that are sent directly to the utility company to defray heating costs for eligible households, and crisis benefits of up to \$600 for households in immediate danger of being without heat. Remember: These are grants and do not have to be repaid.

### School safety a priority for Chester-area school districts

This year, I was proud to congratulate area school districts for securing school safety grants from Pennsylvania's School Safety and Security Committee.

That included a grant of \$443,172 in May for Chester-Upland School District, and then another \$133,635 from the Pennsylvania Department of Education for equipment, programs and school resource and police officers for Chester Community Charter School, The Chester Charter Scholars Academy and Chester-Upland in October.

School safety is, and will always remain, a priority for all of us. I'm hopeful these grants help create an improved feeling of safety and security for our children.

### Let's abolish death by incarceration

In Pennsylvania, if you're sentenced to life in prison, you do not have the possibility of parole. End of story.

That's what our laws say. But our laws need to be reformed.

Not all people sentenced to life in prison are convicted of murder or sex crimes. Some people who receive those sentences, for example, are suffering from the disease of addiction and are handed such a sentence after multiple drug arrests.

I believe that life sentences without the possibility of parole are wrong.

People who have reformed themselves should be able to work toward a path that leads them out of a life behind bars.

House Bill 135 and S.B. 942 – both introduced in 2019 – would not only offer a humane solution to our flawed system, but they would save an incredible amount of money that would otherwise be spent to house and care for people incarcerated for their lifetime.

It is time to end death by incarceration in Pennsylvania.





## **Developments on tap for county parks**

In November, I announced two grants totaling \$97,800 to be used toward local parks and recreation improvements.

The grants were among dozens awarded by the Pennsylvania Department of Conservation and Natural Resources through its Community Conservation Partnerships Program.

Here in Delco, \$57,800 was awarded for rehabilitation and further development of Upland County Park in Upland, plus \$40,000 to Upper Chichester Township to prepare a Comprehensive Recreation, Park and Open Space Plan.

This is outstanding news for both Upland Borough and Upper Chichester, as our local parks and recreation sites provide a necessary sense of community. I'm glad both municipalities will benefit from this funding to improve and develop these spaces.

At Upland County Park, the funding will help construct wall seating, pedestrian walkways, parking area and stormwater management measure, plus the installation of fitness stations and play equipment with required safety surfacing. Additionally, there are site improvements planned related to ADA access, landscaping and more.

### Do you need a REAL ID?

Beginning Oct. 1, 2020, Pennsylvanians will need a REAL ID-compliant driver's license, photo ID card, or another form of federally acceptable identification (such as a valid passport or military ID) to board a domestic flight or enter a secure federal building or military installation.

#### Improving our district

Parts of the 159th earned some substantial grants, loans and tax credits in 2019 aimed at improving our lives in a variety of ways.

#### That includes:

- \$1.4 million for Delaware County family, women, victim and related services from the Pennsylvania Commission on Crime and Delinquency.
- \$113,000 in fresh food grants to elementary schools in Chester-Upland, Chichester and Ridley school districts via the U.S. Department of Agriculture's Fresh Fruit and Vegetable Program.
- \$9.98 million low-interest loan to improve stormwater systems to mitigate localized flooding and erosion and to improve water quality in the City of Chester.
- \$52,000 in tax credits to the City of Chester through the Neighborhood Assistance Program to promote community participation and collaborations among nonprofits, businesses and residents.

My office also regularly reaches out to the community through various events and gatherings, many of which are included in this newsletter. That also includes:

- World Cancer Day Luncheon in Eddystone to provide information and hear stories that touch our hearts.
- Passing out turkeys in Chester and Trainer so folks can enjoy healthier, happier holidays!
