Pennsylvania joined a list of more than 30 states in allowing mail-in ballots for any reason – also known as no-excuse absentee ballots – for the first time in the June 2020 primary.

During the COVID-19 pandemic, mail-in ballots offer members of our community a chance to vote safely from home. It's a secure and convenient option to ensure that your voice is heard. Mail-in voting has the backing of a bipartisan coalition of state officials, including former Republican Gov. Tom Ridge.

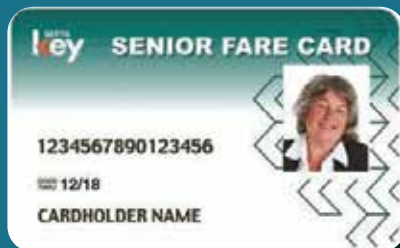
You can apply for a mail-in ballot online – no reason is required – or contact my office for a hard-copy paper application. Also, this November, voting by mail will not cost you. In PA, postage for mail-in ballots will be paid for with federal coronavirus funds.

Apply for your ballot now at [VotesPA.com/ApplyMailBallot](https://VotesPA.com/ApplyMailBallot) to help avoid any delays in returning your ballot. You will be notified when your application is received and when your ballot is received.

At the time of this publication, the deadline to request a mail-in ballot is 5 p.m. on Tuesday, Oct. 27.

## FILL OUT THE 2020 CENSUS

Every 10 years, the United States conducts a census. This count of U.S. residents helps determine how \$675 billion is spent by the federal government and how Pennsylvania is represented in Congress for the next 10 years.

Unfortunately, our community is in danger of being undercounted. This is bad for local schools, our roads and public programs – since federal funds are tied to the census. For every person not counted, our community will miss out on an estimated \$2,000 per year, every year for the next decade.

You can help ensure that our community gets our fair share of funding by responding to the census online at [www.2020census.gov](https://www.2020census.gov), by paper or over the phone.

The last day of September is the final day to self-respond to the census.





# POSITIONING PA TO BE PREPARED

I hosted a House Democratic Policy Committee hearing on Aug. 11 on the challenges of COVID-19 testing. This virus is bad in every way, a threat because in some people its symptoms can be severe enough to kill, while in others, its symptoms can be mild enough to be spread undetected throughout our communities.

In the absence of a safe vaccine, we must improve our testing in Pennsylvania. We acknowledged some of the state's weaknesses.

- The state is testing 4% of our population.
- The wait time for test results must be decreased.
- We must improve the consistency of our data compilation.
- And we must eliminate disparities in testing and health care in our communities, since we've seen lower-income communities and communities with racial minorities at greater risk for outbreaks.

Fortunately, experts confirmed Pennsylvania is doing better than most states, but we want to see more



improvements. The state is taking action, the governor announced this month a partnership with a testing developer to hire 177 new full-time employees.

I am committed to helping the state improve its testing capabilities as we continue to battle this pandemic.



## MASKS MEAN BUSINESS

As we learn more about this deadly virus, including about its potential long-lasting effects, it's important we do whatever we can to stop the spread of COVID-19.

Wearing a mask has been proven to limit the transmission of COVID-19. It does NOT infringe upon your freedom, and in fact helps ensure we can avoid another shutdown in Pennsylvania.

When I go out in public and work in Harrisburg, I wear a mask. Do your part to ensure Pennsylvania remains open and limits the spread of this terrible virus: mask up to protect our community.

# LEGISLATION I HAVE AUTHORED

## DURING MY TWO-YEAR TERM IN OFFICE, I HAVE AUTHORED 12 BILLS AND ONE RESOLUTION

**House Bill 162:** Thousands of guns in Pennsylvania have been trafficked and eventually used in crimes. This bill would help limit the flow of guns to criminals by placing a limit on the number of guns purchased per month.

**H.B. 1527:** This bill would close existing loopholes that allow residents to purchase parts to assemble untraceable “ghost” guns that require no background check or oversight.

**H.B. 2091:** Would ban the use of Chlorpyrifos, a dangerous insecticide originally banned for residential use in 2000 but once again legal in the United States as the Trump administration allowed its reintroduction.

**H.B. 2102:** Southeast Pennsylvania has witnessed bankrupt businesses rewarding executives with millions of dollars in bonuses. This bill would eliminate those payouts to executives if a company has received a public benefit – Such as a state tax incentive or grant.

**H.B. 2228:** Each year in Pennsylvania, dozens of victims of domestic violence are murdered despite receiving a protection from abuse order. This bill would put more protections in place for victims in order to save lives.

**H.B. 2299:** Would update our outdated state law on recycling electronic waste. This bill would cut down on the amount of reusable material in electronic devices that ends up in our landfills.



**H.B. 2642:** Would strengthen worker protections to require companies to inform workers about mass layoffs in a more timely manner.

**H.B. 2643:** Reports indicate unrestricted gifts from opioid pharmaceutical companies to health care professionals may have contributed to our nation’s opioid crisis. This bill would limit pharmaceutical gifts to health care providers to \$50 per year.

**H.B. 2688:** Would strengthen worker protections by forcing companies to provide 180-day notice before mass layoffs.

**H.B. 2693:** Would require applicants for state contracts to disclose all campaign contributions, in effect ending “pay to play” when it comes to awarding state contracts.

**H.B. 2723:** In order to address the high number of residents struggling with opioid use disorder after being originally introduced to opioids through a legal opioid prescription, this bill would provide insurance coverage for evidence-based non-opioid treatments for pain management.

**H.B. 2702:** Establishes a 72-hour waiting period for firearm transfers to provide the time necessary for individuals to gain perspective and seek necessary help when they are making an impulsive decision and considering harming themselves or others.

**House Resolution 318:** Honored the 10th anniversary of the Pennsylvania Innocence Project.
