REGISTER TO VOTE

April 8 – Last day to register for the Primary Election.

April 16 – Last day to request a mail-in ballot.

April 23 – Primary Election Day! Vote in person at the polls from 7 a.m. – 8 p.m. Mail-in and absentee ballots must be returned to Chester County Voter Services or in a secure drop box by 8 p.m.

Remember, your vote is your voice. Make sure you are ready to vote in the 2024 Primary and General Elections.

Property Tax/Rent Rebate

The Property Tax/Rent Rebate Program benefits eligible Pennsylvanians aged 65 and older; widows and widowers aged 50 and older; and people with disabilities aged 18 and older.

Governor Josh Shapiro signed a new law, Act 7 of 2023, to expand the Property Tax/ Rent Rebate Program. With expanded income requirements, nearly 175,000 more Pennsylvanians will be eligible to receive the Property Tax/Rent Rebate in 2024. The majority of the 430,000 past claimants may see increased rebates as well.

The income limit is \$45,000 a year, and half of Social Security income is excluded. Spouses, personal representatives, or estates may also file rebate claims on behalf of claimants who lived at least one day in 2023 and meet all other eligibility criteria. Applications are due by June 30, 2024. If extra funds are available, the deadline is extended to December 31.

SEPTA Cards

Pennsylvanians 65 and older can apply for a free SEPTA Key Senior ID Card or renew their current senior card at my district office. Senior cards can be used on SEPTA trains, buses, trolleys, and subways. Current turnaround time to receive a card is around eight weeks from the application date.

NEW LEGISLATION

STOPPING FINANCIAL ABUSE

Earlier this session, I introduced HB838 to address a common but relatively unrecognized facet of domestic abuse – financial exploitation.

While this form of abuse may be out of the public imagination, financial exploitation is a bitter reality for far too many people.

From deception, intimidation, and undue influence over someone's finances to actively causing financial dependence by interfering with employment or education, financial exploitation takes many forms, and our laws have thus far failed to provide adequate protection.

After much stakeholder input and discussion with colleagues, I plan to introduce a revised version of my legislation, in conjunction with Sen. Judy Schwank, which would widen protections from financial abuse through new torts, enabling victims to seek restitution. This legislation will protect countless families, older adults, and care-dependent persons from this nearly invisible ruination.

PROTECTING EMPLOYEES FROM STALKING

Those working in retail and other public settings, especially minors and young women, are vulnerable to stalking. Required name tags, generally featuring the employee's truthful name, make employees easier for perpetrators to track down, given the prevalence of social media such as Facebook and LinkedIn.

According to the Centers for Disease Control and Prevention, nearly 1 in 6 women and 1 in 17 men will be stalked at some point in their lives. As social media becomes more pervasive, the threat of both cyber and physical stalking becomes greater by the day.

In response to this rising concern, I plan on introducing legislation that would prohibit the use of truthful first or last names on work name tags, therefore protecting the identity of workers. These simple measures will make the workplace safer for millions of people across Pennsylvania at very little cost to the Commonwealth or the employers.

CONSERVATION CORNER

PRIVATE LANDOWNER ASSISTANCE PROGRAM

A team of Pennsylvania Game Commission biologists is ready to assist you in making your property more attractive for wildlife, particularly species of greatest conservation need. They even make house calls!

The Pennsylvania Game Commission, responsible for managing the state's wild bird and mammal populations, created the program with the goal of improving Pennsylvania's landscape for wildlife species of special concern through developing detailed plans for interested landowners who want to help these at-risk species. These plans focus on creating or maintaining habitat for the state's 109 bird and mammal species of concern. Although the plans focus on species of concern, a wide variety of species often benefit from these habitat plans once they are implemented.

This program is custom-made for landowners who are interested in creating, preserving, or enhancing wildlife habitat. And remember, every habitat improvement made in support of species of concern solidifies their future in the Commonwealth. Progress is made in the Private Landowners Assistance Program every time another landowner gets involved. The goal of this program is to make private properties better for these species at least one property at a time.

The first step is to contact the regional wildlife diversity biologist or regional office serving your county. After a short interview, the biologist will send the interested property owner a landowner objective survey, which identifies the property by habitat features and ranks the landowner's interests and property uses. After reviewing the survey, the biologist will visit the property and walk it with the landowner. A detailed plan will be developed based upon the biologist's findings and landowner's chosen level of involvement.

There is no charge for participating in the program, nor is there a public access requirement. Biologists will follow up their planning effort by checking with participating landowners to see if they have questions or need additional direction.
