STURLA SECURES EDUCATION FUNDING

Following Rep. Sturla's work as Co-Chair of the Basic Education Funding Commission, he introduced H.B. 2370 to make Pennsylvania's public education system more equitable and adequate. The House passed this bill in bipartisan fashion to make it a part of the state budget negotiations. As a result, Rep. Sturla helped secure a historic \$1.3 billion in education funding, including local **increases** for:

- School District of Lancaster by \$6,836,057
- Manheim Township School District by \$3,283,106
- Hempfield School District by \$2,336,536

2024-25 PA BUDGET HIGHLIGHTS

Rep. Sturla voted for the bipartisan 2024-25 state budget and below are notable highlights. For all details, go to www.houseappropriations.com.

Historic Education Funding

Over \$1.3 billion will be invested in all students via basic education funding, special education funding, Ready to Learn Block Grants for Adequacy and Tax Equity, cyber charter changes and safety grants. Specifically:

- **\$526 million** to level the playing field and help homeowners who've been shouldering the heaviest burden to pay for their schools.
- **\$100 million** more to help districts teach kids with special needs.
- \$60 million starting Jan. 1 for real cyber charter reform, putting it back in the pockets of taxpayers by treating cyber charter schools like the taxpayer-funded schools they are – and finally delivering accountability on special education.
- \$225 million to make sure every district keeps the money they're already investing – delivering stability to schools, plus another \$60 million to help struggling districts.
- **\$100 million** for school safety, including improving mental health resources for students in crisis.
- **\$100 million** to clean up and improve school facilities.
- **\$30 million** increase for Career and Technical Education.

Higher Education

To keep the best and brightest in PA so they can learn and earn. This budget delivers student-first improvements like a smoother path to graduation, improving access to grants and loans, and reducing the student debt load.

- The new **\$25 million** Grow PA Scholarships Program will get more students in the most needed careers like nursing and teaching.
- Doubles the Student Teacher Stipend Program to **\$20 million.**
- **\$54 million** increase for PHEAA to maintain maximum State Grants.

- **\$36 million** increase for the Ready to Succeed Scholarships.
- \$35.1 million increase for state system schools.
- **\$15.7** million increase for Community Colleges.

Economic Development

This budget spurs job creation to make Pennsylvania more competitive with economic development nationally.

- **\$500 million** to develop more commercial and industrial sites.
- **\$20 million** for the Main Street Matters program to support small businesses.
- **\$20 million** for small minority-, women-, and veteran-owned businesses.
- **\$15 million** for tourism marketing to attract more visitors.

Human Services

A variety of increases were made to help make lives better.

- **\$261 million** for Intellectual Disabilities-Community Waiver Program.
- **\$71 million** for mental health services.
- **\$26.2 million** for subsidized child care services.
- **\$12.6 million** for Long-Term Managed Care to help keep seniors in their homes.

Affordable Housing

This budget raises the cap for PHARE funding to \$100 million per year by 2026, nearly doubling the state's commitment to building more affordable housing. It also includes a \$5 million increase for homeless assistance, \$2.5 million for emergency housing support, and \$2.5 million for legal assistance to those facing eviction proceedings.

STURLA CONTINUES COMMITTTEE'S WORK ON HOUSING

VOTING DEADLINES

The voter registration deadline is Oct. 21 to vote in the General Election on Nov. 5. The deadline to apply for mail-in and absentee ballots is Oct. 29. You can do both online at **vote.pa.gov**.

HOUSE PASSES CO-SPONSORED LEGISLATION

Here is a list of legislation co-sponsored by Rep. Sturla that recently passed the House:

- H.B. 78 to create the PA Medical Debt Repayment Program for low-income Pennsylvanians.
- H.B. 98 to ensure workers receive equal pay for equal work.
- H.B. 777 to close the loophole in state law that treats "ghost guns" like any other firearm.
- H.B. 1140 to preserve access to birth control.
- H.B. 1512 to ensure telemedicine access.

CHESAPEAKE BAY COMMISSION MEETING



In May, Rep. Sturla participated in the Chesapeake Bay Commission's meeting at the University of Maryland Center for Environmental Science Appalachian Laboratory in Frostburg, MD. Located at the headwaters of the Chesapeake Bay, this laboratory's scientists advise state, national and international leaders on air and water quality, wildlife management, forest and agricultural management, and biodiversity conservation. HELP FOR VETERANS AND THEIR FAMILIES

People are often not aware that there are many state and federal programs available to veterans and their families. Starting on Sept. 10, an American Legion Department Service Officer will be available in Rep. Sturla's Lancaster office on the second Tuesday of each month between 10 a.m. and 1 p.m. to provide free assistance with veterans' benefits, scholarships, health benefits, survivor benefits, and more. Appointments must be scheduled ahead of time by calling Rep. Sturla's office at (717) 295-3157.

PA SENIOR FOOD BOX PROGRAM

The Senior Food Box Program is available year-round for low-income seniors 60 years and older. Rep. Sturla's office can assist with applications, or you can enroll at Lancaster County Food Hub. Qualifying applicants will receive a monthly box with foods such as non-fat dry and shelf-stable fluid milk, juice, oats, ready-to-eat cereal, rice, pasta, dry beans, peanut butter, canned meat, poultry, or fish, and canned fruits and vegetables. PENNIE ENROLLMENT

To get financial assistance to help lower the cost of health insurance coverage, Pennsylvanians can enroll in 2025 coverage via Pennie from Nov. 1, 2024 until Jan. 15, 2025. For more info, go to **Pennie.com** or call Pennie at 1(844) 844-8040.


COLLECTING TOYS FOR TOTS
