I was proud to help secure funding for Wesleyville's Police Department to acquire Ke\$ha the K-9! Ke\$ha is a 2-year-old female Dutch Shepherd from the Netherlands and is nationally certified as a dual-purpose narcotics and patrol K-9.

The Erie Police Department's Saturation Unit received an equipment upgrade in the form of 10 new e-bikes! My colleague, state Rep. Pat Harkins, and I secured a grant to help purchase these e-bikes, helping these dedicated public servants continue keeping Erie residents safe.

These new e-bikes will allow officers to interact more with community members and cover a larger area of the city while on patrol.





Our valiant first responders put their lives on the line daily to safeguard our communities from fires, accidents, and various emergencies. They have earned our deepest thanks and support. In recognition of their bravery, we have successfully obtained over \$190,000 in grant funding for Erie County's fire and EMS departments since the start of 2024.



As vice chair of the PA House Game and Fisheries Committee, I work closely with outdoor enthusiasts, including the SONS of Lake Erie, on ways to support and enhance fishing on Lake Erie and its tributaries.



I extend my gratitude to the Girl Scouts of Western Pennsylvania at St. Luke School for inviting me to discuss the Pennsylvania General Assembly. The girls posed insightful questions and shared brilliant ideas! With such scouts at the helm, our future is indeed promising!



The Boy Scouts of America do incredible work in encouraging young people to become the best version of themselves. I was honored to support Boy Scout Troop 1333 at their Spaghetti Dinner. I must say, the food was delicious. Great job!



Residents of Erie County deserve a public transportation system that is safe, clean, reliable, and affordable. We had a productive discussion with Jeremy Petersen, Executive Director of the Erie Metropolitan Transit Authority, on shared goals and priorities to expand and enhance EMTA's offerings of public transit.



It was a tremendous honor to celebrate Edward J. Kuchcinski, a WWII veteran, on his 98th birthday. Not only did Ed turn 98 years young, but he also marked his 67th wedding anniversary with his beloved wife, Dorothy. Ed's military decorations and citations include the Army of Occupation Medal, the European African Middle Eastern Campaign Medal, and the World War II Victory Medal. Lt. Governor Austin Davis and Acting Secretary of the Pennsylvania Department of Health Dr. Debra Bogen convened a roundtable discussion in Erie with local public health experts and community stakeholders to spotlight proposed investments aimed at tackling the gun violence epidemic and enhancing the safety of Pennsylvania communities and families.

BRINGING YOUR TAX DOLLARS HOME

Tax dollars should remain in Erie to be reinvested in enhancing resources for families and students, bolstering programs for veterans and seniors, supporting small businesses, developing infrastructure, and ensuring community safety.

In the first six months of 2024, I have worked to secure \$10 million, including:

- \$3.1 million to electrify Erie's fleet of refuse collection trucks.
- \$1.4 million for the installation of ADA-compliant sidewalks & ramps in Erie.
- \$1.4 million to bolster safety and mental health resources in Erie schools.
- \$835,000 for violence intervention and prevention efforts.
- · \$710,000 to improve water quality.
- · \$660,000 to improve access to safe, affordable housing.
- \$700,000 to bolster broadband access in Erie County.
- · \$260,000 to protect and preserve Lake Erie.
- · \$200,000 to bridge the digital literacy gap.
- · More than \$190,000 for Erie fire and EMS companies.
- Nearly \$170,000 for the enhancement of Erie police, code enforcement vehicles.
- Nearly \$160,000 to support technical schools throughout Erie County.
- Nearly \$100,000 to improve Wesleyville Borough's police fleet.
- · More than \$100,000 to bolster indigent defense in Erie.
- \$80,000 to fight veteran hunger, food insecurity.
- \$55,000 to illuminate the Bayfront Connector.
- \$40,000 to enhance student safety on college campuses.

DEADLINE TO APPLY FOR PROPERTY TAX/RENT REBATE PROGRAM EXTENDED UNTIL DEC. 31

Great news! The Pennsylvania Department of Revenue recently extended the deadline to apply for the state's Property Tax/Rent Rebate Program.

Older adults and Pennsylvanians with disabilities 18 or older have until Dec. 31 to apply for the Property Tax/Rent Rebate Program. The Department of Revenue began issuing rebates on July 1, so the sooner you apply, the sooner you will receive your rebate.

Starting this year, the maximum rebate is \$1,000 on rent or property tax paid in 2023, and the income limit is \$45,000 annually for both homeowners and renters. Those income limits will be tied to the cost of living moving forward, which means the people who receive a rebate will not have to worry about losing their eligibility through no fault of their own in the years to come.

FIGHTING TO LOWER COSTS FOR SENIORS ...

My legislation making it easier for seniors to qualify for a reduced vehicle registration fee has been enacted into law! The proposal I championed and shepherded through the legislative process raised the qualifying income cap from \$19,200 to \$29,906, allowing more retirees to renew their annual vehicle registration for only \$10, with subsequent annual adjustments based on the Consumer Price Index.

The enactment of my proposal will ease the financial burdens associated with vehicle ownership for retirees living on a fixed income. The recent boosts to Social Security payments pushed many retirees above the income threshold to qualify for a reduced vehicle registration fee.

My legislation that was signed into law by Governor Shapiro fixes that problem, demonstrating our ability to work in a bipartisan fashion to solve the complex issues facing Pennsylvanians.



... AND TO ESTABLISH SAFEGUARDS FOR AI

Artificial intelligence is a rapidly evolving tool that is becoming increasingly prevalent in our day-to-day lives. While the technology holds great promise in areas such as medical research and diagnostics, it can also pose a dangerous threat in the wrong hands, especially when used to spread disinformation. To harness this powerful technology, we need to understand how to best manage it.

That's why I have been championing two bills that would establish crucial guardrails for AI.

The first would require a disclosure on any content generated by Al. People have a right to know whether the content they

are viewing was generated by a person or a computer. The bill passed the House and is currently in the state Senate.

I have also introduced legislation to protect the sanctity of our electoral process from false Al-generated content. Voters deserve accurate information about candidates before they go into a voting booth. My bill would impose civil liability and potential court penalties for disseminating an Al-generated impersonation of a candidate within 90 days before an election that is designed to misrepresent their words, actions or beliefs.

The bill recently passed out of committee and will head to the full House chamber for a vote.
