On July 16, Pennsylvania's Secretary of Health Dr. Rachel Levine and Secretary of Education Pedro Rivera released guidance on how our K-12 schools can safely reopen for the fall and educate students for in-person learning.

Resuming school this year will be a complicated and emotional process. As always in education, there is no one-size-fits-all answer for supporting the physical and mental health of every child. Every 10 years, the United States conducts a census. This count of U.S. residents helps determine how \$675 billion is spent by the federal government and how Pennsylvania is represented in Congress and in the General Assembly for the next 10 years.

You can help ensure that our community gets its fair share of funding by responding to the census either online at www.2020census.gov, by paper or over the phone.

Funding based on the census helps improve roads and bridges, access to quality public education and improves our public safety, so make sure you get counted!

VOTER'S GUIDE

Voting by mail

For the first time, Pennsylvanians were able to vote by mail this past June. This quickly became a popular option as we practiced strict social distancing measures, and over 1 million people voted by mail for the primary. Since we are unsure what the fall will bring with COVID-19, I strongly encourage everyone to utilize this safe, secure and convenient choice. If you'd prefer to vote in person, that option will still be available to anyone interested.

Applying for a mail-in ballot is easy and only takes about 5 minutes. Refer to the infographic to the right for instructions on how to get started.

Register to vote

If you are at least 18 years old or will be by Nov. 3, make sure you're registered to vote! If you're not, visit VotesPA.com/Register or scan this QR code. The application process takes about 15 minutes.


If you're not sure that you are registered at your current address, you can check at VotesPA.com/Status.

Throughout the pandemic, I've been checking in with small businesses throughout our community so I can bring their needs to Harrisburg and show them my support.

Help for small businesses

The COVID-19 pandemic has taken a serious toll on many small business owners. Please know that I've been working in Harrisburg to secure financial aid to help our area businesses stay afloat and survive this public health crisis.

In July, I hosted a webinar for business owners on how to apply for rescue funding and how to navigate the appropriate state systems. Some of those funding opportunities have since closed but others are still available, and new ones are in the works. Open programs as of Aug. 14 include:

- **SBA Economic Injury Disaster Loans**

Low-interest loans still available to eligible small businesses and agricultural businesses with 500 or fewer employees. These loans may be used to pay fixed debts, payroll, accounts payable and other bills that can't be paid because of the disaster's impact. The interest rate is 3.75% for small businesses without credit available elsewhere; businesses with credit available elsewhere are not eligible.

- **Grant opportunities for non-profits**

- **COVID-19 Relief Small Business Assistance Grant Program (second round)**

Businesses must apply through a partnering Community Development Financial Institution. Visit www.pabusinessgrants.com for resources, including an application checklist, eligibility details and a full list of participating CDFIs.

- **SBA Disaster loans for damaged or destroyed property**

Delco homeowners, renters and businessowners impacted by the recent instances of civil unrest in our area may be eligible for low-interest disaster loans through the SBA Disaster Loan Programs. Funds may be used to restore damaged or destroyed buildings, inventory, equipment and assets. Economic Injury Disaster Loans may also be used to pay fixed debts, payroll, accounts payable and other bills that can't be paid because of the disaster's impact.
