Dear Neighbor,

Greetings neighbors! I am thrilled to announce that 2023 was an incredibly successful year for the 157th Legislative District. My office was able to help more people than ever with their questions and state government needs - in fact, we helped almost 5,000 of you! We were particularly delighted that over 500 seniors visited our office for a SEPTA pass.

On the legislative front, being in the House Majority matters! During the 2023 session, I introduced or co-sponsored 49 bills, seven of which passed the House and TWO bills were enacted into law. HB 1259 was folded into the Fiscal Code bill passed by the General Assembly and signed in to law by Gov. Shapiro to become the expanded Child & Dependent Care Enhancement Tax Credit. The work of HB 1118 was completed by the Shapiro administration when they terminated state funding of crisis pregnancy centers.

While it is always satisfying to look back and celebrate our achievements, there is still more work to be done for the people of Pennsylvania. Looking ahead, we are excited to continue serving our community and making 2024 another successful year for the 157th Legislative District.

2023-24 BUDGET FINALIZED

At the end of 2023, Governor Shapiro signed Act 34 into law, a bipartisan package of fiscal bills that completed the 2023 state budget. This means more money for our schools, safer communities, smart criminal justice reform, and expansion of the child and dependent care tax credit. This will put more money back into the pockets of working families.

JOBS/APPRENTICESHIPS

■ \$23.5 million was earmarked for workforce training and vo-tech programs to prepare students for family-sustaining skilled trade careers and \$6 million for pre/apprenticeship programs so Pennsylvanians can earn-while-they-learn.

EDUCATION FUNDING

■ The Tredyffrin-Easttown, Great Valley, and Phoenixville School Districts saw an average increase of 10.1% in funding received from the state thanks to the 2023-24 budget.

■ The PA State System of Higher Education institutions, as well as community colleges, also saw an increase in funding.

EXPANDED PROPERTY TAX/RENT REBATE

■ The income eligibility limit for both homeowners and renters is now \$45,000, and the maximum rebate has been increased to \$1,000, enabling more people to afford basic necessities and stay in their homes.







LEGISLATIVE UPDATES

GOVERNOR SHAPIRO TOUTS TAX CREDIT IN BERWYN

I was honored to welcome Gov. Shapiro to our district to celebrate the expansion of the Child & Dependent Care Enhancement Tax Credit. This tax credit will put money into the pockets of working families by relieving some of the financial burden of childcare. Expansion of the tax credit is a personal matter for me. When I was raising my son as a single, working mother, access to reliable and high-quality childcare was critical for me to pursue my career and provide a better life for us. Representative Tina Davis and I initially introduced this legislation, and it took a coalition of legislators, working parents, and business chambers led by Laura Manion of the Chester County Chamber of Business & Industry to make it a reality. Incorporating this tax credit in the Fiscal Code means that working women are being SEEN for their important economic role in our Commonwealth.







TACKLING YOUTH HOMELESSNESS

Many young people are facing homelessness due to various factors that are entirely out of their control. This situation can have a devastating effect, especially on young individuals who are still developing and trying to find their place in the world. As a result, my colleagues and I have introduced several bills (HB 127, HB 729, HB 730, HB 1175) to provide youth with the necessary resources to learn, be safe, and succeed. I introduced HB 1175 for colleges, which would create an oncampus pilot program to ensure homeless students have access to secure housing, food, laundry facilities, technology, and other services. This initiative aims to enable them to concentrate on completing their education without having to worry about basic needs.

UNIFORM FAMILY LAW ARBITRATION ACT

A constituent in my district was going through a messy divorce because her exhusband had the means to manipulate our legal system. Through an extraordinary number of court filings, court dates, and legal fees, he



continued to harass his former partner. This kept her from work, from her education, and - most importantly - away from raising their daughter. None of this benefited their child or aided the legal process. It only added an extra and unnecessary burden on our already strained family court system. Sadly, this is very similar to my own personal experience.

I testified before the State Senate Judiciary Committee urging them to pass HB 917, legislation I introduced because Pennsylvanians should have a choice in how they settle their family disputes. The Uniform Family Law Arbitration Act will level the legal playing field, saving families time and money, while reducing stress on our court system and our children.

COMMONSENSE GUN LEGISLATION

The House Judiciary Committee recently voted to advance a package of five commonsense gun bills, including my legislation, HB 1190, which would update our laws to regulate 3D-printed guns like standard firearms. This legislation is essential to reducing gun violence in our communities and will give law enforcement the tools they need to keep our families safe. These bills have been sent to the full House for a vote.

ANTI-HATE CRIME LEGISLATION

One look at the headlines, and it's evident that hate crimes are on the rise. These crimes aimed at individuals based on their race, religion, sexual orientation, or any other characteristic, have devastating effects on the victims and their communities. Everyone has the right to live each day without fear. That's why I voted for a package of Anti-Hate Crime legislation (HBs 1024, 1025, 1027) that would add penalties for perpetrators if a crime is motivated by hate. I also voted to invest in the safety of our communities by increasing security funding (HB 1772) for groups that may be targeted.

PENNSYLVANIA'S NEW WOMEN'S SERVICE PROGRAM

The PA Dept. of Human Services has launched a new statewide program dedicated to providing accessible and inclusive health care to pregnant and parenting women. The Women's Service Program will receive funds formerly allocated to deceptive crisis pregnancy centers. Since 1995, unregulated crisis pregnancy centers received over \$135 million in taxpayer dollars and yet did not provide adequate medical care services, nor contraceptive care, to the women of PA. Moving forward, for Chester County and the SEPA region, the Maternity Care Coalition will be granted these state funds to provide reproductive health services. This is a huge victory for women in PA and I am proud that legislation I introduced, HB 1118, was a catalyst for getting women the care they really need.

ABORTION SHIELD BILL - HB 1786

Since the Supreme Court Dobbs decision, women living in states with abortion bans have been forced to travel to other states to access essential healthcare. Rep. Mary Jo Daley and I were prime sponsors of HB 1786, which would protect patients



and reproductive healthcare providers in Pennsylvania from out-ofstate prosecution. This bill passed with bipartisan support and is a significant victory for women, as it has been more than a decade since the PA House passed legislation to safeguard abortion rights.

NO PELVIC EXAMS WITHOUT CONSENT ACT

Until now medical students have been able to perform invasive pelvic, rectal and prostate exams without consent on patients who are under anesthesia for medical training purposes, not for the health of the patient. I voted in favor of HB507, introduced by Rep. Fiedler, to protect patients' rights, and I am proud this important legislation was signed into law by Gov. Shapiro.

PROTECTING REPRODUCTIVE FREEDOM - HB 1888

The House Judiciary Committee also heard compelling testimony from women and doctors about their deeply personal and painful experiences with medically complicated pregnancies. They chose to share these powerful stories in support of HB 1888, introduced by Rep. Danielle Friel Otten, a proposed state constitutional amendment guaranteeing reproductive liberty in Pennsylvania. As a member of the Judiciary Committee, I voted "Yes" on this amendment because women deserve the right to necessary healthcare.

OPEN PRIMARIES - HB 976

When I first ran for election, people would say, "I love what you are doing, but I am never going to join your political party, and I want to be able to vote for you." Because of that experience, I voted YES on HB 976, introduced by Rep. Brown, which would create "Open Primaries" in Pennsylvania. This would allow more than 740,000 registered unaffiliated voters, many of whom serve in our military, to participate in the democratic process.

BOOK BAN HEARING

When I was a child, I spent countless hours at my local library, where I was introduced to a diverse array of opinions that helped shape my worldview as an adult. Being exposed to many, sometimes challenging, perspectives didn't indoctrinate me as a child or cause me to develop radical views as an adult. Instead, weighing opposing opinions enabled me to hone a more informed and nuanced approach to the world around me. Recently, I had the opportunity to express my opposition to banning books during a policy hearing. In my opinion, the freedom to read and access information is essential for leading a well-rounded, enriched life.



LEAF BLOWER TASK FORCE

Did you know operating a commercial 2-stroke gas leaf blower for one hour releases the same amount of air pollution as driving a car for 1,100 miles? PennEnvironment recently published a new study on the impact of this gas-guzzling equipment, and the data is staggering. As a result, I am proposing a taskforce to work with lawncare industry stakeholders and scientists to develop financial incentives to phase out gas-powered equipment without impacting businesses and jobs.
