# BILLS DESIGNED TO PROTECT WILDLIFE, FARMS AND FORESTS

Farmers are being financially crippled by crop damage, while our woodlands are being decimated by the deer herd, and the legacy of hunting is waning. These bills are a collaborative effort with many organizations to revive hunting, while also being stewards of our wildlife and natural resources.

**H.B. 2106** — Permit Sunday hunting through June 30, 2029. Sunday hunting would NOT be permitted in any of the 100 state parks that are normally open to hunting. It also would increase the penalties for hunting on private land without permission.

**H.B. 2107** — Connect farmers to licensed hunters to manage deer populations on their property. The Pennsylvania Game Commission would create an online registry that farmers could access.

**H.B. 2108** — Require at least one member of the Pennsylvania Board of Game Commissioners to have experience in the agriculture industry. This would put a person knowledgeable in wildlife management on the board.

## PROTECTING PUBLIC HEALTH



With more driveway sealants available that are safer for public health and the environment, we should eliminate the sealants that are toxic.

**H.B. 1166** — Ban coal-tar-based sealants for driveways and parking lots because they are high in PAHs – polycyclic aromatic hydrocarbons, which can endanger public health and the environment. With more sealants that are safer, we should eliminate the sealants that are toxic to the health of Pennsylvanians.

#### MAKING MENTAL HEALTH A PRIORITY



As the mother of four children, I worry about their mental health, just like many parents. This bill would prioritize students' mental health and well-being to help them better meet life's challenges with greater resilience.

**H.B. 1665** — The School Counseling Services Act would require schools to implement comprehensive counseling services that provide support to all students, and direct school counselors to spend at least 80% of their time providing student services.

# STUDYING THE MARCELLUS SHALE IMPACT FEE

Pennsylvania imposes an impact fee on drilling in the Marcellus Shale, but other states collect severance taxes. Which one is fairer to the state and to the company? That's what this resolution will find out.

**H.R. 131** — The Legislative Budget and Finance Committee will study and compare impact fees and severance taxes in the top five gas-producing states and examine the competitive business climate for the industry in those states.

#### **UNEMPLOYMENT FOR STRIKERS**

Undertaking a strike is a serious decision; it's not made lightly and usually happens after negotiations have reached an impasse. This bill would:

**H.B. 1481** — Provide financial relief for striking workers by permitting them to qualify for unemployment compensation benefits.

## **INSURANCE COVERAGE FOR BP MONITORS**

Hypertension and related disorders are a leading cause of maternal, neonatal and fetal health complications and death. Early identification and intervention is critical to the health of the mother and baby. Remote blood pressure monitoring is a reliable, effective strategy in getting control of the mother's blood pressure and avoiding costly and preventable complications.

**H.B. 2138** — Require insurance coverage for home blood pressure monitors for pregnant women.

## **ALLEGHENY SHORES PROJECT MOVING FORWARD**

Things are happening for the Allegheny Shores project that stretches from the Allegheny RiverTrail Park in Aspinwall to 13th Street in Sharpsburg.

The project recently received nearly \$35 million in combined federal/state funding.

More than 50 acres will be revitalized along the Allegheny River that has been historically separated from the community by a rail corridor for nearly 100 years. Major improvements in

transportation access and mobility, enhancement of regional trail networks and revitalization of the waterfront will help connect residents with the river and breathe new life into the area.

This important revitalization of a brownfield site has regional implications throughout the Allegheny Valley, and it is exactly the kind of project that we need to encourage in our small riverfront communities. I'm proud to support this project.

I've been committed from Day 1 to making sure our communities get their fair share of state grant funding, and so far communities in the upper part of the district have received **more than \$6.6 million** in the last 18 months alone. It's my privilege to secure this funding. Here is a sampling of the grants I have obtained so far:

- \$3.9 million for water, stormwater and wastewater improvements to improve access to drinking water and improve waste disposal.
  - Water treatment plant rehabilitation, new water tank and pumping station for Tarentum
  - Improve stormwater conveyance and water distribution systems in Harrison Township
  - Waterline replacements along Bull Creek Road and extension along Bakerstown Road in Fawn Township for the Fawn Frazer Joint Water Authority
  - Replace storm sewer along Morgan street in Brackenridge
- \$950,000 for various transportation and pedestrian safety improvements, including a traffic signal upgrade and pedestrian safety at the intersection of Freeport and Springhill roads in **Harrison Township**.
- \$1.15 million for municipality/recreation improvements.
  - Emergency generators for Allegheny Valley North Council of Governments
  - Athletic field improvements, including new turf, scoreboard for Highlands School District
  - Establish a trailhead for Three Rivers Water Trail in Harrison Township and adding ADA accessibility and crosswalk along Sycamore Street and River Road
  - · Replace the roof and fix parking lot of Fawn Township's municipal building
  - Replace Brackenridge Borough's public works garage
- \$191,000 for public safety.
  - Vehicle camera system for Tarentum Police Dept. and wireless cameras for Fawn Township Police Department
  - Speed enforcement devices for Harrison Township Police Department
  - Repaving parking lot and rehabbing building for Hilltop Hose Co. in Natrona Heights
  - Communication platform for Tarentum Borough

These are state dollars going to work right here in our neighborhoods to improve residents' quality of life, and I continue to work to bring state money back home to benefit the district.

## FIRST RESPONDERS CORNER

One of my jobs as state representative is to fight for state funding for local communities and organizations at home. I'm pleased to note that recently, I was able to obtain \$18,043 for the Southern Allegheny County Emergency Services, formerly known as the Aspinwall and Sharpsburg Volunteer Fire departments. The merged fire department used the funding to pay for the new signage on all vehicles, buildings and new uniforms for the 30 firefighters. I also secured \$50,000 for the Allegheny Valley Regional Police Department's new pickup truck they recently added to their fleet.

I also wanted to take this opportunity to thank area first responders for their cooperation and partnership to make my recent events a success for the community. Thanks to them and everyone who participated, 154 fire alarms were installed, area children learned bicycle safety and were able to get up close to emergency vehicles and see the equipment firsthand, and many drivers were able to get their illegible license plates replaced.
